# Comelec to hold 2nd bidding for 2025 poll automation project on Jan. 8

MANILA – The Commission on Elections (Comelec) is set to conduct a second bidding for the lease of Full Automation System with Transparency Audit/Count (FASTrAC) for the 2025 midterm elections.

In an advisory, the poll body's Special Bids and Awards Committee (SBAC) invited prospective bidders to submit bid documents in time for Monday's bidding at 10:30 a.m., which will be held at the Convention Hall, Bureau of the Treasury (BTR) on the 3rd Floor of the Palacio del Gobernador in Intramuros, Manila.

Aside from private companies, the commission is also expecting observers from the Commission on Audit (COA) Resident Auditor, Parish Pastoral Council for Responsible Voting (PPCRV), National Citizens' Movement for Free Elections (NAMFREL), Legal Network for Truthful Elections (LENTE), Democracy Watch, and Participate PH to attend the bidding.

"Members of the media are invited to cover livestream will be available on the Official Comelec Facebook page (facebook.com/comelec.ph) and YouTube Channel (youtube. com/COMELEC)," it added.

Meanwhile, an election watchdog urged the Comelec to thoroughly check the background of one of its bidders for the multi-billion project.

Democracy Watch said the poll body must scrutinize the South Korean firm Miru Systems Co. Ltd. after claims that it was involved in alleged poll issues.

"We urge the Comelec to give Miru's track record a thorough once-over as part of its due diligence, as it should with all suppliers. It might want to investigate the company's alleged links to controversies in Congo and Argentina. Such concerns over hacking vulnerabilities and vote manipulation are so grave as to have prompted watchdog groups and independent experts to flag many fatal weaknesses in Miru's technology publicly," it said



"We trust that the Comelec will raise these issues in the interest of ensuring the integrity of the 2025 elections. We cannot have counting machines failing at such a massive scale, as this would cause political instability in the country."

Based on the latest available data showing Miru's performance in six nations where it facilitated automated elections failed in at least three countries mainly due to issues with voting machines.

Democracy Watch, an official observer to the Comelec's ongoing procurement process for next year's polls, issued the statement after the first round of bidding for the PHP18.83 billion contract failed.



# PNP eyes stronger anti-cybercrime drive in 2024

MANILA – Philippine National Police (PNP) chief Gen. Benjamin Acorda on Wednesday ordered all police regional offices to strengthen their campaign against cybercrimes.

"So part of our 2024 plans, looking forward is to intensify the capability enhancement of the police in addressing this aspect of criminality. In dissecting our crime statistics, although the crime volume went down, we noticed that the cybercrimes

or crimes on the internet like scamming, are still there," Acorda said in a radio interview.

Acorda said while the capability of the force's Anti-Cybercrime Group significantly improved through training and procurement of more equipment, he cited the need for more efforts not only in terms of cyber-patrolling and solving cybercrime but also in encouraging the public to trust the PNP's capability in addressing their concerns.

"While we do aggressive police operations, we want it done honestly and another one is integrity enhancement to really get the support of the people," said Acorda.

In the first eight months of 2023, the ACG investigated a total of 16,297 cybercrime cases.

It also issued 19 warrants to search, seize and examine computer data, served 214 arrest warrants, conducted 140

entrapment operations and provided technical assistance to 24 ongoing investigations by other units and agencies.

These efforts have resulted in the arrest of 397 individuals and the rescue of 4,092 victims, mainly during operations against human trafficking.

In the last four months of 2023, the ACG saw a slight decrease in cybercrime cases.

A total of 4,362 cyber-

crime cases were recorded from September to December last year, from 5,607 cyber-crime cases logged in the same period in 2022.

In terms of the PNP's performance in 2023, Acorda believed that they did better as manifested by high trust ratings of the police based on some surveys.

# CSC calls for nominations in 2024 Search for Outstanding Gov't Workers



MANILA – The Civil Service Commission (CSC) is currently accepting nominations for the 2024 Search for Outstanding Government Workers through its Regional Offices, with the deadline for online submission set for March 31, 2024.

As part of the government's rewards and incentives mechanism under the Honor Awards Program (HAP), the annual search aims to recognize civil servants who have shown utmost dedication and commitment to their work, as well as to inspire other state and nomination forms are employees toward deeper involvement in public service.

All government workers in the career and non-career service including appointive barangay officials may be nominated. Employees who are under Job Order or Contract of Service are excluded from the coverage of the program.

Civil servants with exceptional achievements of national impact may be nominated for the Presidential Lingkod Bayan Award, while those whose contributions resulted in innovations, digital transformation, or other positive changes within their region, agency, or department are eligible for the CSC Pagasa Award.

Meanwhile, public servants who consistently displayed exemplary and ethical behavior in the face of risk or temptation inherent in their work may be nominated to the Outstanding Public Officials and Employees (Dangal ng Bayan) category.

Posthumous nomination may also be accepted for public servants who died in the line of duty or in the pursuit of their official duties and responsibilities. The nomination must be made within 12 months from the time of death.

Awardees will be entitled to rewards and incentives, including cash prizes, automatic promotion or salary increase equivalent to the next higher position, one-time executive check-up, and scholarship opportunities with any of CSC's partner educational institutions, among others.

# Deaths due to fireworks rise to 2

MANILA - The Department of Health (DOH) on Friday reported a second death due to fireworks, also from the Ilocos Region and a companion of the first fatality.

The additional fatality was a 44-year-old-male who was in the same blasting incident reported by the DOH on

The first recorded death was a 38-year-old male who lit a cigarette while drinking with his companions near a firecracker storage.

The DOH also reported 15 new cases -- four more confirmed stray bullet injuries (SBIs) and 11 fireworks-related injuries.

The new confirmed SBIs were a 28-year-old female from Calabarzon Region who sustained a gunshot wound to her right arm while watching fireworks outside their home; a 22-year-old female (left ear) and her 26-year-old brother (upper right back) from the Ilocos Region after their neighbor fired a gun; and a 22-year-old male from Northern Mindanao (right arm).

From Dec. 21, 2023 until 6 a.m. of Jan. 5, the DOH has recorded 600 injuries -- 592 due to fireworks, one ingestion and seven SBIs.

Fifty-three are still in hospitals.

More than half or 313 cases are from the National Capital Region; 61 are from the Ilocos Region; 49 are from Calabarzon; and 42 are from Central Luzon.

The regions with the lowest number of injuries are Davao with two cases; Eastern Visayas, 3; and Mimaropa, 3.

About 64 percent of the fireworks related injuries are caused by kwitis (mini skyrocket), Five Star, "Pla-pla," Whistle Bomb, luces (sparklers), boga (improvised cannon) and fountain fireworks. (PNA)

# DOTr chief: No basis to raise minimum fare to P50

MANILA - Department of Transportation (DOTr) Secretary Jaime Bautista has belied the claim of a commuters' group that the minimum fare for modern jeepneys would increase to PHP50 after the implementation of the public utility vehicle (PUV) modernization program.

In a statement on Thursday, Bautista explained that the primary consideration for any fare increase in public transport is the cost of fuel.

"We strongly believe there is no basis on the alleged PHP50 minimum fare," he said.

Fare increase petitions are subject to the en banc deliberation of the Land Transportation and Franchising Regulatory Board (LTFRB), he added.

"It will also require NEDA (National Economic and Development Authority) opinion as to the inflationary effect of any increase, as well as giving due consideration to affordability of the commuting public," Bautista said.

In a television interview, commuters group PARA-Advocates for Inclusive Transport

said the PUV modernization program comes with a financial burden for jeepney operators and drivers.

fare increase would be for operators to pay for the loans, apart from earning a living.

The current minimum fare is PHP13 for traditional jeepneys and PHP15 for modern jeepneys.

In 2017 when the PUV modernization program began, the minimum fare was PHP9 for traditional jeepneys and It said the basis for the PHP11 for modern jeepneys.

> "This showed that LTFRB has always balanced the need of drivers against commuters when fuel price increase happens," Bautista said.

> > Under the modernization

program, the consolidation deadline for jeepney operators and drivers – the first phase of the program – was on Dec. 31,

Jeepney operators and drivers who failed to join the PUV modernization program will be allowed to operate beyond the Dec. 31 consolidation deadline but only in routes that have few consolidated units. (PNA)


