DSWD calls for stronger support to promote digital safety of children

MANILA - A senior official of the Department of Social Welfare and Development (DSWD) has called for full implementation of the law to protect children against online sexual abuse or exploitation.

DSWD Undersecretary for International Affairs, and Attached and Supervised Agencies (ASAs) Emmeline Aglipay Villar made this call during the Safer Internet Day for Children Philippines (SID PH) 2024 at the SMX Convention Center in Pasay City on Feb. 13.

Villar, alternate co-chair to the Inter-Agency Council Against Trafficking (IACAT), underscored the need to strengthen efforts towards the prevention and protection of children from risks and abuses in the digital world through the implementation of Republic Act No. 11930 or the "Anti-Online Sexual Abuse and Exploitation of Children (OSAEC)" and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM) Act.

"The full implementation of the law requires us to unite and amplify the mechanisms and systems of concerned government agencies, private entities, and partner institutions to block and filter the dissemination of online child sexual abuse material and child sexual exploitation materials," Vil-

"However, we must also strengthen our efforts in terms of capacitating other stakeholders, the children themselves, parents, guardians, relatives, and their communities to arm them with the necessary knowledge to be responsible digital users themselves," she added.

The DSWD pushed for the establishment of the National Coordination Center Against Online Sexual Abuse or Exploitation of Children and Child Sexual Abuse or Exploitation Materials (NCC-OSAEC-CSAEM) one-stopshop processing center for victim-survivors of OSAEC and other related cases of abuse and exploitation of chil-


The two-day activity was aimed at providing children and youth participants with a platform for meaningful conversations and dialogues regarding their digital life, the advantages, risks, and responsible use of the internet and social media platforms.

The SID PH 2024 banners the theme, "OSAEC at CSAEM

The DSWD is in the process of further strengthening its Recovery and Reintegration Program for Trafficked Persons (RRPTP), the flagship program of the Department in providing comprehensive and holistic psychosocial services for victim-survivors of Trafficking in Persons (including OSAEC), their families, and communities.

The DSWD is also conducting capacity building for duty bearers and service providers specifically in the agency's regional offices and Local Social Welfare and Development Offices to enhance their skills in providing programs and services to OSAEC victims. (PNA)



Gov't agencies, LGUs begin talks on regulating use of e-bikes

government agencies and local government units (LGU) on Thursday began discussions on regulating the use of e-bikes and other unregistered electronic vehicles (e-vehicles) nationwide.

The meeting was held at the headquarters of the Metropolitan Manila Development Authority (MMDA) between officials of the MMDA, Department of Transportation (DOTr), Land Transportation Office (LTO), Land Transportation Franchising and Regulatory Board (LTFRB), Department of the Interior and Local Government (DILG), and traffic heads of LGUs in the National Capital Region (NCR).

During the meeting, MMDA acting chair Don Artes said the proliferation of e-vehicles has become a "cause concern."

"The LGUs have laid down their concerns, existing ordinances, regulations, and programs concerning e-vehicles. These will be reconciled with the policies of the national government," Artes said.

Vendors of e-vehicles, he said, often cite that, unlike regular motor vehicles, e-vehicles are neither required to be registered nor need a license to

"When these e-vehicle users violate the law, how can we issue a traffic violation ticket if the users do not possess a license? We also cannot charge the vehicle owners because they are not registered," he said.

In addition to being a "grave risk" to their drivers, other motorists, and pedestrians, he said e-vehicles also slow down the flow of traffic.

MANILA – Several national Many of their drivers have also been monitored to be minors, do not wear helmets or other protective gear, and some use their e-vehicles in the middle of highways.

> "We will consolidate and harmonize all existing rules and regulations, as well as ongoing programs of the LGUs and even national government concerning e-vehicles to make it comprehensive. This will also cover not just Metro Manila but nationwide," he said. Metro Manila LGUs have been asked to submit a list of their ordinances regarding the regulation of e-vehicles, particularly those used for commercial purposes.

> "We will take a second look at the suggestions of the LGUs and propose the appropriate measures to regulate the use of e-vehicles in major thoroughfares," he said.

In addition, LTFRB chair Teofilo Guadiz III said e-trikes are also a concern of the public utility vehicle (PUV) modernization program (PUVMP) as these compete with legitimate PUVs in getting passengers.

"We are coordinating with the MMDA and LTO to apprehend these units that do not have franchises to operate as PUVs," Guadiz said.

The meeting was led by Artes, Guadiz, LTO Chief Assistant Secretary Vigor Mendoza II, DOTr Undersecretary Jose Lim, and several other national and local government officials. (PNA)

DA encourages Calabarzon farmers to use new hybrid rice varieties, fertilizers

CALAMBA CITY, Laguna (PIA) — The Department of Agriculture (DA) in Calabarzon is urging farmers to utilize new hybrid rice varieties and various types of fertilizers to boost rice production in the region.

In a recent Hybrid Rice and Fertilizer Derby exhibition in Sariaya, Quezon, more than 800 farmers from different provinces evaluated the hybrid rice varieties and fertilizers formulated by various local companies.

The department highlighted that hybrid rice varieties are the result of the first generation of breeding two finest rice varieties with the best quali-

"Hybrid rice varieties are heavier, longer, and have more grains per tuft of rice compared to inbred rice," said DA IV-A in a statement.

To provide additional knowledge and skills to rice farmers regarding new rice farming technologies, participating farmers were divided into groups for a field walk where they observed crops and visited the booths of participating companies showcasing various fertilizer products, pesticides, herbicides, and more. This was followed by a discussion where farmers were free to ask questions.

Julian Trinidad, the president of Concepcion Pala-

san Farmers Association in Sariaya, Quezon, emphasized the importance of attending such activities that help him and his group improve their capabilities and learn more techniques in rice

farming.

"I am delighted that we were among those who were able to witness the various varieties of hybrid rice and fertilizers because we are being educated on modern technology, strategies, and methods for the advancement of our rice farming," Trinidad said.

implemented well with very good teachers in the field, could greatly support our learning recovery efforts and help improve student learning outcomes," Duterte said.

She also thanked the 35 schools that piloted the curriculum in seven regions.

"With your pioneering efforts, with your participation, we gain needed insights and get practical insights on the challenges of implementation and the probable solution to address that," she said.

In terms of getting the feedback and experiences of teachers in pilot schools, Duterte mentioned that she may visit the "35 schools since there are 365 days in a year."

To date, there are five regions implementing the said curriculum, with around 385 and 8,294 participating teachers and learners, respectively.

These include schools in Metro Manila, Cordillera Administrative Region, Caraga Region, Ilocos Region, Cagayan Valley, Central Visayas, and Soccsksargen.

The DepEd, meanwhile, held the national summit to consolidate reported challenges and concerns from the pilot implementation of the MATATAG curriculum, identify strengths to be sustained, and come up with a "synchronized mechanism of support" for the measure.

The MATATAG Curriculum, piloted in September last year, aims to decongest

He said the average monthly road crash incident is 1,740.
