

Whole-of-government approach vital to mitigating El Niño effects – NIA

National Irrigation Administration (NIA) Calabarzon whole-of-government proach in mitigating the effects of El Niño in the region.

During the Sulong Calabarzon program of the Philippine Information Agency, senior engineer Precious Leirae Palagency is proactive in fulfilling its mandate in providing and establishing a working and efficient irrigation system that will help Filipino farmers increase their harvest and productivity, even during the dry season.

Palacol stated that the agency adheres for the call of a wholeof-government approach by President Ferdinand Marcos, Jr. to prepare and address the crop varieties to help Filipino effects of El Niño in various parts of the country, including the Calabarzon region.

> The irrigation administration has its own El Niño Action Plan, which contains different innovation measures for cultivating crops that include a water delivery schedule, utilization of Alternate Wetting and Drying (AWD) Technology, diversification of crops, and the use of drought-resistant farmers.

In Calabarzon, the agency has identified a total of 3,322



hectares as vulnerable areas in the region susceptible to the impacts of El Niño, including the provinces of Cavite and Batangas. "NIA Calabarzon has identified a total of 3,322 hectares as vulnerable areas covering the entire Calabarzon region, which consists of various provinces in Region IV-A. Currently, our field offices are continuously monitoring our irrigation systems and we are maintaining communication with our farmers to assess the status of their farmlands," Palacol said.

She added that as soon as PA-GASA announced the onset of El Niño, registered Irrigators Associations (IA's) in the region were immediately notified by their field officers and urged to adopt diversified cropping practices, as rice cultivation demands more water supply during this period.

"There are several farmers coming to our field offices to convey their concerns about the drought they are experiencing, like in Nasugbu and Lian, Batangas, which have been affected by the dry spell. NIA immediately responded by cleaning our irrigation canals and drainage systems,' Palacol explained.

For its part, NIA regularly conducts desilting activities in irrigation systems' main canals to remove accumulated trash and mud within the system, which has affected the source of water on farmlands.

The agency calls on the residents near irrigation systems to do their part by responsibly discarding trash away from irrigation canals or drainages to prevent any obstruction and ensure a proper flow of water.

Amidst the imminent challenges brought by El Niño, Palacol said that the agency continuously coordinates with farmers and counterpart agencies to contribute to the aspiration of the administration to attain food security nationwide. (CO/PIA-4A)

Marcos signs law prohibiting 'no permit, no exam' policy

MANILA - President Ferdinand R. Marcos Jr. has signed into law a measure prohibiting the "no permit, no exam" policy to allow disadvantaged students to take scheduled periodic and final examinations despite unsettled financial obligations.

In a statement on Saturday, Communication Secretary Cheloy Garafil said Marcos signed Republic Act (RA) 11984, or the "No Permit, No Exam" Prohibition Act on March 11.

Garafil said RA 11984 covers all public and private basic education (K to 12) institutions, higher education institutions, and technical-vocational institutions (TVIs).

"Students with unpaid tuition and other school fees could now take periodic and final examinations, following President Ferdinand R. Marcos Jr.'s signing of Republic Act 11984," she said.

Garafil said all covered public and private educational institutions found guilty of violating RA 11984 will be subject to administrative sanctions that may be imposed by the Department of Education (DepEd), Commission on Higher Education (CHED),



and the Technical Education and Skills Development Authority (TESDA).

Under RA 11984, all public and private educational institutions are mandated to accommodate and allow disadvantaged students with unpaid tuition and other school fees to take the periodic and final exams without requiring a permit.

In the case of K to 12 students, the mandate will be for the entire school year, according to the new law.

Garafil said RA 11984 should be implemented without prejudice to the right and power

of the educational institutions to require the submission of a promissory note, withhold the records and credentials of students, and such other legal and administrative remedies available to them for the collection of unpaid fees.

The law mandates the Department of Social Welfare and Development (DSWD) to issue the necessary certificate on the disadvantaged status of the student due to calamities, emergencies, force majeure (uncontrollable events), and other good or justifiable reasons.

The issuance of certificates by the municipal, city, and provincial social welfare and devel-

opment officer, or the regional office of the DSWD should be in accordance with the agency's implementing rules and regulations.

Garafil said the DSWD, in consultation with all relevant stakeholders, shall promulgate the rules and regulations defining "disadvantaged student" and the criteria and requirements for the effectivity of the issuance of necessary certifications by different entities involved to effectively carry out the law.

MANILA – The Department of Agriculture (DA) on Friday assured of sustained stringent monitoring amid an armyworm infestation in some onion plantations in the country, and will closely monitor the peak harvest for onions from Laurel Jr.])," de Mesa said. March to April.
