Marcos: Gov't working to address flooding woes soonest

MANILA - As the Philippines enters the rainy season, President Ferdinand R. Marcos Jr. assured the public Thursday that the government is working to address the country's problems on flooding "as soon as possible."

In a speech during the distribution of assistance to farmers, fisherfolk, and families in Tagum City, Davao del Norte, Marcos said he has ordered the Department of Public Works and Highways (DPWH) to fasttrack the completion of flood control projects.

"Pagsusumikapan natin na sa mas lalong madaling panahon ay walang Pilipinong nakalubog sa baha at sa kahirapan. Ito po ang Bagong Pilipinas (We will work hard to ensure that no Filipino will be drowned in flooding or poverty. This is the New Philippines)," Marcos said.

"Sa panahon ng tagtuyot at tag-ulan, kaagapay niyo kami sa pagbangon tungo sa mas maunlad na buhay (In times of drought or rainy season, we are with you every step of the way toward a more prosperous

life)," he added.

Last week, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) officially announced the start of the rainy season.

It also warned that there is a high chance of La Niña developing during the July-September period.

According to the weather bureau, La Niña would increase the likelihood of above-normal rainfall in parts of the country, especially toward the end of the year.



DSWD assists 2K survivors of sexual abuse, trafficking in 2023

MANILA - In its continuing efforts to protect Filipinos from sexual abuse, exploitation, and trafficking, a senior official of the Department of Social Welfare and Development (DSWD) on Thursday reported that the agency has provided various interventions to 2,024 victim-survivors of Trafficking in Person (TIP) in

Of this figure, 320 were minors rescued from Online Sexual Abuse or Exploitation of Children (OSAEC), Anti-Child Sexual Abuse or Exploitation Materials (CSAEM), and trafficking.

"We at the DSWD reaffirm our commitment to protect the welfare of these vulnerable children. We recognize the urgency of President Ferdinand R. Marcos Jr.'s directive to implement a comprehensive and intensive action plan to combat OSAEC and CSAEM," DSWD Assistant Secretary for Disaster Response Management Group (DRMG) Irene Dumlao said in a news release.

In a sectoral meeting on Tuesday, President Marcos said the country "is not a safe haven for people who abused and exploited children. This is the absolute worst place for you, and we will make sure you know it."

Out of the 2,024 clients served in the different DSWD Field Offices, 824 or 40.7 percent TIP victim-survivors were male and 1,197 or 59.14 percent were female.

In cases involving children, 16 belong to 0 to 6-year age group, 101 are 7 to 12 years old, and 203 are 13 to 17 years

Through the DSWD's Recovery and Reintegration Program of Trafficked Persons (RRPTP), the agency provides a comprehensive program that ensures adequate recovery and reintegration services to victim-survivors of trafficking, OSAEC, and CSAEM.

The victim-survivors were provided with a wide array of services including logistical support during and post-rescue operations; temporary shelter; support services such as transportation, medical and educational assistance; and economic reintegration services which include skills training, and financial assistance for employment and livelihood.

"These services were also provided to the families of victimsurvivors," Dumlao, who is also the DSWD spokesperson,

She said the DSWD is conducting a series of workshops and capacity building for its field offices' personnel to ensure effective and efficient implementation of the program and its responsiveness to the needs of the victim-survivors of trafficking.

The DSWD, she added, also continues to enhance its existing policies and conduct advocacy activities to prevent people from becoming victims of human trafficking.

"As the Co-Chair of the Inter-Agency Council Against Trafficking, and a member of the National Coordination Center Against OSAEC and CSAEM, the DSWD commits to intensify our efforts for the prevention, advocacy, protection, recovery, rehabilitation, and reintegration of trafficked persons," Dumlao said. 


its poverty incidence to a sin-



AMILY OF SLAINED **DRUG SUSPECT CRIES JUSTICE**

San Juan, Batangas - The family of a slained drug suspect is seeking justice following the death of their relative in an alleged anti-illegal drugs operation by elements of San Juan Municipal Police Station in Batangas.

Bryan Laresma alias "Balot," 33, of Barangay San Isidro, Candelaria, Quezon was killed in what police claimed as a shootout, a day before his child's graduation day on May

The alleged clash occurred in the boundary of Tiaong, Quezon and San Juan in Batangas at around 6:30 p.m. Tuesday.

Adrian Laresma, Bryan's brother, said they want justice for his sibling's death.

"Magkikita po kami ng kapatid ko nang araw na iyon para iabot sa kanya ang pambili ng solar fan na ireregalo niya sa graduation ng kanyang anak. Kitang-kita ko po nung binaril na walang kalaban-laban ang kapatid ko," (My brother and I were supposed to meet on that day so I can give him the money to buy a solar fan which will be his gift to his daughter on his graduation day. I saw when he was shot without a fught.), Adrian said in an interview by mediamen on Friday.

According to Adrian, Bryan was about to alight from his motorcycle when shot by a member of the San Juan Municipal Police Station.

"Pababa po ng kanyang motor ang kapatid ko nang biglang barilin ng pulis San Juan. Wala naman pong bentahan akong nakita. Bigla na lang pong binaril ang kapatid ko sa hita, (He was about to alight from a motorcycle when a police officer shot him on his leg), added the brother who was also in the

Bryan succumbed to blood loss while being brought to San Juan District Hospital.

"Ang nakakapagtaka po, may ospital na malapit sa pinangyarihan pero bakit po sa malayong ospital dinala ang aking kapatid," (I don't understand why policemen brought him to a far hospital when there is one nearby) said Adrian.

The brother also claimed that the incident happened in Tiaong, Quezon where San Juan Municipal Police has no jurisdiction.

Adrian, whose statement was corroborated by chairman Rico Macaraig of Bgy. del Rosario, Tiaong, Quezon.

Bryan's uncle, Nelson Dimailig, former chairman of Bgy. Bantilan in Sariaya, Quezon said they will seek the help of the National Bureau of Investigation (NBI) for the reautopsy) of his nephew's body and the Commission on Human Rights (CHR) to give justice for Bryan.

According to Dimailig, Bryan left behind his wife and seven children.

Meanwhile, the San Juan police report stated that seized from the slain suspect were two heat-sealed transparent plastic sachets containing five grams of suspected shabu worth P34,000, the P500 buy-bust money, and a cal. 38 loaded with two cartridges and four live ammunition.
