I 20K indigents served under Bagong Pilipinas Serbisyo Fair in Cavite

At least 120,000 indigent residents get various services and assistance from the national government through the Bagong Pilipinas Serbisyo Fair (BPSF) in Cavite on Friday.

Speaker Martin Romualdez and 200 members of the House of Representatives attended the service caravan at the Emilio Aguinaldo Elementary School in Kawit, Cavite.

"Together with our lawmakers, we are bringing meaningful change to our communities," Romualdez said, expressing optimism about the continued success of the BPSF.

The BPSF in Cavite is part of a broader initiative aiming to visit all 82 provinces in the country, bringing government services closer to the people.

Romualdez noted that the services provided such as cash and medical assistance, scholarships, and livelihood programs worth PHP1 billion, had a positive impact on the lives of thousands of Caviteños.

"With this kind of cooperation and participation, we are ensuring that government services reach even the farthest corners of the country," he stated.

Romualdez said a total of 25,000 Caviteños also benefitted from President Ferdinand R. Marcos Ir's three revolutionary financial assistance programs that were also rolled out in Cavite to help more vulnerable sectors, students, and struggling small entrepreneurs.

Romualdez said the Cash Assistance and Rice Distribution (CARD) Program, Integrated Scholarships and Incentives for the Youth (ISIP) Program, and the Start-Up, Investments, Business Opportunities and Livelihood (SIBOL) Program continue to provide relief to citizens in need.

"I am very pleased that these programs continue to flourish and continue to provide muchneeded aid to our citizens who are not included in established social amelioration programs like the 4Ps," he said.

For the CARD program, a total of 10,000 beneficiaries from all over Cavite each received PHP5,000 in cash assistance as well as 10 kilograms of rice in a simple distribution ceremony at the Imus City Grandstand.

Romualdez is the main proponent of this program, which assist vulnerable sectors such as indigent senior citizens, persons with disabilities, single parents, indigenous peoples, and others to aid in the daily cost of living.

The fund used for the cash assistance came from the Ayuda Para sa Kapos ang Kita Program (AKAP) of the Department of Social Welfare and Development (DSWD).

For the ISIP for the Youth another program crafted by Speaker Romualdez – a total of 5,000 students received PHP5,000 in financial aid and five kilograms of rice in a distribution ceremony held at the Bacoor Elementary School. Beneficiaries from this program receive financial assistance as they pursue tertiary and vocational education, to aid them in their continued education.

The funds used for this came from the Assistance to Individuals in Crisis Situations (AICS) of the DSWD.

Benefits for students enrolled in this program include enrollment under CHED's Tulong Dunong Program (TDP) where students can get scholarship assistance per year amounting to a total of P15,000; priority slots under the Government Internship Program (GIP); and enrollment of their unemployed parents or guardians to the DOLE-TUPAD Program.

The distribution ceremony for the SIBOL Program took place at the Maple Grove in General Trias and saw 10,000 MSME beneficiaries each receiving PHP5,000 in financial assistance and five kilograms of rice. The funds used for this program also came from

Julita Trinidad, a resident of Mary Cris Homes in Imus, thanked the national government for providing financial assistance to the indigent residents like her.

Bong Go visits Dasmariñas City

Dasmariñas City - Senator Christopher "Bong" Go continues his efforts to bring public services closer to Filipinos especially the poor, the sick and the needy. As Chair of the Senate Committee on Health and Demography, he emphasized the necessity of ensuring that every Filipino has access to healthcare as well as assistance for vulnerable sectors.

On Wednesday, September 25, Go personally attended the inauguration ceremony of the new Super Health Center in Dasmariñas City, Cavite and assisted impoverished residents in the city in partnership with Mayor Jenny Austria-Barzaga.

A total of 1,667 individuals, including PWDs, Parents of SPED, Women, Solo Parents, and Senior Citizens gathered at the Dasmariñas Arena received additional support from Go, such as food packs, snacks, vitamins, masks, shirts, foldable fans, and basketballs and volleyballs. Some beneficiaries also received shoes, a mobile phone, bicycles, and a watch.

Being an adopted son of CALABARZON region, Go also partnered with the local government of Dasmariñas City led by Mayor Bargaza in providing financial support to the identified indigent sectors present.

Apart from supporting vulnerable sectors during his visit, Go also led the inauguration of one of his key advocacies for the community which is the establishment of its own Super Health Center. He emphasized the significance of building such healthcare facilities as part of his continued commitment to enhancing healthcare accessibility across the nation.

Go reiterated his commitment to support the establishment of more Super Health Centers across the country considering how they can significantly

help reduce hospital occupancy rates while bringing primary medical services closer to the grassroots. Super Health Centers can offer primary care, medical consultation, and early disease detection, further strengthening the healthcare sector at the community-level.

Through the concerted efforts of Go, fellow lawmakers, the Department of Health (DOH) led by Secretary Teodoro "Ted" Herbosa, and local government units, adequate funding was allocated for establishing more than 700 Super Health Centers nationwide, including 17 in Cavite.

Meanwhile, in support of community health front liners, Go also gave grocery packs, snacks, shirts, and basketballs and volleyballs to 205 barangay health workers (BHWs) and Barangay Nutrition Scholars (BNS) present.

Responding to the earnest pleas of health workers, Go mentioned that he has been urging the DOH and the Department of Budget and Management (DBM) to act swiftly on releasing the long-overdue Health Emergency Allowance (HEA) of qualified health workers.

Go also expressed gratitude to the local government for their diligent efforts in making the Super Health Center a reality.



He specifically thanked Mayor Austria-Barzaga, Board Members Jun dela Cuesta, and Nickol Austria, and local councilors, among others.

Mayor Bargaza then expressed her deep gratitude to Go for his unwavering support to the city, particularly in health services and infrastructure proj-

Meanwhile, Go offered additional aid to individuals with medical needs and advised them to avail themselves of the assistance provided by nearby Malasakit Centers located at the Southern Tagalog Regional Hospital in Bacoor City and Gen. Emilio Aguinaldo Memorial Hospital in Trece Martires City.

Malasakit Centers are onestop shops for medical assistance programs aimed at helping impoverished patients reduce their hospital costs to the least possible amount. Go is the principal author and sponsor of Republic Act No. 11463, or the Malasakit Centers Act of 2019, which institutionalized the Malasakit Centers program.

As of now, 166 Malasakit Centers are operational nationwide, poised to assist with patients' medical expenses. The DOH reports that the Malasakit Centers program has already provided aid to nearly 12 million Filipinos.

Earlier, Go supported other projects in the city as the vice chairperson of the Senate Committee on Finance, including the concreting and improvement of Local Access Roads in Barangay San Miguel I & II, construction of Slope Protection along Imus River, Revetment East Side of Barangay Burol Main, acquisition of trucks, and ambu-

lances, among others.



four months after the start of classes will receive 45 days of VSCs per year," the DepEd said in a statement.

According to the DepEd, VSCs are leave credits earned by public school teachers for services rendered during summer or long vacation, Christmas vacation, weekends, and holidays, as well as for teaching overload.

Under the new guidelines, teachers are allowed to "offset absences due to sickness or personal reasons or to recover salary deductions during vacation periods."

For regular school days' overtime service credits, teachers earn 1.25 hours of VSC per hour of eligible service rendered; and 1.5 hours of VSC per hour of rendered service during weekends, Christmas, and other holidays, as well as summer breaks.

"In cases where teaching overload is not compensated through overload pay, teachers will be credited with 1.25 hours of VSC for every hour of additional teaching, on top of their 30-day entitlement," the DepEd said.

The new guideline also covers ancillary tasks or additional teaching-related tasks beyond working hours which include training during weekends or holidays, remedial or enhancement classes, electionrelated duties, parent-teacher

conferences and home visits.

Its procedure will be streamlined, with the approval coming from the authorized Schools Division Superintendent or another designated authority. (PNA)





Embryo Transfer Technology, a new era in goat farming in Cagayan Valley

THE goat-raising industry in the Philippines is set to benefit from a groundbreaking technology innovation, as the Department of Science and Technology Region 2 (DOST 2), in collaboration with the Isabela State University (ISU) and DOST-PCAARRD, reported the successful implementation of its Embryo Transfer (ET) Technology for goats.

The development was announced by DOST-PCAARRD Executive Director Dr. Reynaldo V. Ebora during the 2024 Regional Science and Technology Week (RSTW) held in Cagayan Valley.

Ebora said five kids were successfully produced using the ET technology, which is part of the Innovative Systems in Advancing Technology-Based Goat Production project funded by the DOST-PCAARRD.

Dr. Ricmar P. Aquino, ISU president, emphasized the importance of technological innovations in goat production, and highlighted key technologies such as semen collection, semen processing, and artificial insemination for small ruminants to modernize goat production and enhance the efficiency and profitability of goat farming.

Science and Technology Secretary Dr. Renato U. Solidum Jr. said the Embryo Transfer Technology enables the production of multiple offspring from a single female goat, significantly enhancing reproductive efficiency.

The process involves superovulation to maximize the oocyte reserves of a female goat, followed by the transfer of fertilized embryos to recipient females. The method increases both the number of offspring and the speed of genetic exchange between herds, thus accelerating the improvement of goat breeds.

The total goat inventory in the Philippines has declined in re-



cent years. The current inventory is estimated at 3.86 million heads, a decrease from previous counts, with over 99 percent of the country's goat population sourced from small-hold farms.

The situation highlights the pressing need for improved goat meat production to meet rising demand. Goat meat, or chevon, has been gaining popularity due to its lower calorie, cholesterol, and saturated fat content compared to other meats such as beef, pork, and chicken.

Additionally, the goat industry provides not only nutritious meat and milk but also supports agricultural diversification and offers a vital source of income for small-scale farmers.

Dr. Cristino Nayga delivered the first embryo transfer (ET) kid in June 2023, with four additional kids produced from three other dams in the following months. The kids were derived from dams with a 75 percent Boer bloodline mated with purebred Boer bucks.
