

DOLE, other gov't agencies reaffirm commitment to combat child labor

The Department of Labor and Employment (DOLE) in Calabarzon, together with its partners, has vowed to strengthen its efforts and collaboration to end child labor in the region.

In celebration of the fifth anniversary of the institutionalization of the National Council Against Child Labor (NCACL) recently, various government agencies signed a memorandum of understanding affirming their commitment and support to eliminate child labor in Calabarzon.

These agencies include the Department of Health (DOH), Department of Education (DepEd), Department of Social Welfare and Development (DSWD), Department of Justice (DOJ), Philippine Statistics Authority (PSA), National Economic and Development Authority (NEDA), Philippine National Police (PNP), and the Philippine Information Agency (PIA). In her message, DOLE Assistant Secretary Amuerfina R. Reyes emphasized the significance of sectoral collaboration through the establishment of NCACL in achieving a child labor-free Philippines and ensuring firm protection for the rights and welfare of every child.

"This council, composed of 19 government agencies and representatives from the employer sector, worker sector, and non-government organizations, represents a whole-ofgovernment and whole-of-society approach. We are all in this together, working hand in hand for the future of our youth," she said.

She added, "We hope to see a day in our country when there are no longer issues or problems with child labor, and every child in the Philippines will have the opportunity to study, live comfortably, and have a bright future."

Joseph Torado, 44, a farmer from Rizal Province and fa-



ther of a former child laborer in the region, thanked DOLE for the support and interventions they received under the agency's Integrated Livelihood Program. He stated that the assistance from DOLE has brought substantial gains for his family and improved the education of his children.

Angel Noreen Manambay, a former child laborer and now a beneficiary of the Government Internship Program, expressed her gratitude for the government's support through DOLE, which helped her continue her studies despite a lack of financial resources.

"Now, I am a beneficiary of the Government Internship Program at the Rizal Provincial Office. Because of this opportunity, I have been able to help my family, and I am happy to be working in a good environment. That's why I am now one of those helping and inspiring other child laborers to continue their studies," she said.

As part of the celebration of NCACL's institutionalization, DOLE organized a service caravan to raise awareness about the causes and effects of child labor among identified child laborers and The labor department also awarded livelihood assistance and offered several services, including free medical consultations, laboratory tests, tooth extractions, oral prophylaxis,

The BIR director also urged business owners to fulfill their tax obligations and comply with the national tax code to contribute to the country's development.

the road. That is why we issued an SCO against the owner and driver of the vehicle involved)," Mendoza said.

The vehicle's owner – a resident of Sta. Mesa, Manila – was asked to appear before the LTO central office on Tuesday.

It also required the owner and the driver during the incident to submit a written explanation why they should not be held liable for cases of Reckless Driving under Section 48 of Republic Act (RA) 4136 (An Act to Compile the Laws Relative to Land Transportation and Traffic Rules), Driving While Under the Influence of Liquor or Narcotic Drug under the law's Section 53, and Improper Person to Operate a Motor Vehicle under Section 27 (a).

The maximum penalty for these offenses is revocation of the driver's license.

"Failure to appear and submit the written comment/ explanation as required shall be construed by this Office as a waiver of your right to be heard, and the case shall be decided based on the evidence at hand. In the interim, your driver's license and the subject motor vehicle are placed on alarm pending this investigation," the SCO read.

The investigation is in response to a viral video originally posted on Instagram by a page called "Hombre Estu" captioned "drunk driving at BGC" showing an incident

that happened along 7th Avenue on Sept. 23.

In the video, the driver was seen driving towards the opposite direction of a oneway street and deliberately swerving the vehicle. (PNA)



Saturday said no Filipino was hurt in two air raids conducted by the Israeli army in Beirut on Oct. 10.

The strike was described as the deadliest so far in the fight between Israel and Hezbollah, hitting densely populated areas that resulted in 22 fatalities and 117 injuries.

"Sa ngayon, wala tayong napapabalitaan na nasaktan o nasawing Pilipino sa mga attack sa Lebanon (At present, we haven't heard any Filipino hurt in the attacks in Lebanon), whether in southern Lebanon or in Beirut," DMW Secretary Hans Leo Cacdac said in an interview on the sidelines of the Saturday News Forum in Quezon City.

"Sa awa ito ng Diyos kaya't we're hoping it will stay that way (This is by God's grace and we hope that it will stay that way)," he added. It advised all Filipino nationals in Beirut to avoid affected areas, particularly Ras al-Nabaa and Noueiri.

Cacdac said majority of the 11,000 Filipinos in Lebanon are residing and working in the capital city.

At present, about 570 have expressed their interest to voluntarily leave Lebanon, 221 of whom have already secured flights from Oct. 12 to 28.

The exit papers of the remaining 350 are being processed by the Philippine Embassy.

Cacdac said at least 178 Filipinos are being housed in shelters and hotels across Lebanon. (PNA)

"Please take notice that the Commission (en banc) approved the extension of the deadline for the filing of Petitions Against Nuisance Candidates from Monday, 14 Oct. 2024 to Wednesday, 16 Oct. 2024, from 8 a.m. to 5 p.m., in view of Comelec Memorandum dated 11 October 2024, in relation to Memorandum Circular No. 66 of the Office of the President on work suspension in the Cities of Manila and Pasay on 14 and 15 October 2024," it said.

In its memo dated Oct. 11, the poll body noted that the extension is pursuant to the order of Malacanang suspending gov-
