# PI33-M worth of medical aid sent to 'Kristine'-hit areas: DOH

MANILA – The Department of Health (DOH) has sent out PHP133 million worth of medical and public health emergency supplies, water sanitation and hygiene kits in areas hit hardest by Severe Tropical Storm Kristine (international name Trami).

Health Secretary Teodoro Herbosa on Friday said teams deployed from its regional offices and hospitals found that the highest illness reported is respiratory infection.

"Mr. President, for the human resources. We've actually deployed our teams from the regional offices and hospitals, so they're actually there," Herbosa said during a situation briefing with President Ferdinand R. Marcos Jr. in Malacañang.

The medical teams distributed face masks and appropriate medicines while concerned local government units provided modular tents per family to contain the spread of infection, Teodoro said.

He also reported that added.

there were several barangay health stations and hospitals damaged due to the weather disturbance.


"Two big hospitals in Bicol, Bicol Medical Center and Bicol Regional Medical Center in Albay, the one in Naga and one in Albay are both functional, although we lost power and we also lost damage to the internet server of our vehicle Medical Center. But the hospitals are functioning," Herbosa said.

"We have a couple of hospitals that are functional in Batangas, but cannot be accessed because of floods," he

Meanwhile, about PHP6.8 million has been allocated for nutrition and PHP1.8 million for psychosocial support of the storm victims.

Earlier, the DOH has activated Code Blue - the highest health emergency response to disaster - in Cagayan Valley, Bicol Region, and Ilocos Region

The agency maintains Code White in the National Capital Region, Central Luzon, Mimaropa, Western Visayas and the Bangsamoro Autonomous Region of Muslim Mindanao.

## NDRRMC: 'Kristine' death toll rises to 13

MANILA – The death toll from the effects of Severe Tropical Storm Kristine (international name Trami) has climbed to 13, the National Disaster Risk Reduction and Management Council (NDRRMC) said Friday.

The disaster response body's latest situation report said 11 deaths were logged in Bicol, one in Central Visayas, and one in Calabarzon.

Only the fatality in Calabarzon has been confirmed while the rest are being validated.

Also being confirmed are re-

ports of seven missing persons

five in Bicol, one in Cala-

barzon, and one in the Ilocos

region – as well as five injured persons – four in Bicol and one in the Bangsamoro Administrative Region in Muslim Mindanao (BARMM).

A total of 569,524 families or 2,656,466 persons residing in 3,483 barangays in 15 regions were affected by the storm.

Of these, 64,447 families or 239,200 individuals are taking shelter in 5,791 evacuation centers while 19,961 families or 80,497 persons are being aided outside evacuation centers.

In the same update, 1,402 houses were reported damaged in 11 regions. (PNA)

## DA readies over P80-M agri aid in 'Kristine'-hit areas

MANILA – The Department of Agriculture- Disaster Risk Reduction and Management (DA-DRRM) Operations Center on Thursday prepositioned PHP80.21 million worth of agricultural aid to farmers in areas affected during the onslaught of Severe Tropical Storm Kristine (international name: Trami).

The amount aims to cover the distribution of agricultural inputs including seedlings of rice, corn, high-value crops, drugs, and biologics.



## DOH distributes hygiene kits, meds to 'Kristine' victims

MANILA – The Department of Health (DOH) on Thursday provided medical interventions in evacuation centers in areas affected by Severe Tropical Storm Kristine (Trami) in the Bicol region.

The members of its Health Emergency Response Team from different regions distribing the initial assessment of the evacuation centers.

There is enough supply of disinfectants, chlorine granules, and aquatabs that are important in accessing clean water and sanitation in evacuation centers, it added.

The agency said the local

Besides this, farmers can also avail of the PHP25,000 loanable amount payable for three years with zero interest, as well as the indemnification for insured farmers through the Philippine Crop Insurance Industry (PCIC).

In a statement, DA Secretary Francisco Tiu Laurel Jr. said partial reports of agricultural damage are being validated to ensure the mobilization of aid for immediate recovery.

"For now, we have to wait for the actual report to ascertain the damage and the interventions that we need to do to help our farmers and fisherfolk recover quickly from this calamity," he said.

As of Thursday, the DA-DRRM said at least 2,864 farmers were affected in the Cordillera Administrative Region (CAR), Mimaropa, Bicol, and Western Visayas.

Agricultural damage also rose to PHP80.80 million from almost PHP10 million on Wednesday.

Majority of the damage was recorded in the rice sector, amounting to PHP79.34 million in Kalinga, Oriental Mindoro, Marinduque, Camarines

Norte, Camarines Sur, and Negros Occidental.

Damage in corn production followed at PHP1.34 million in Camarines Sur, Marinduque,

and Masbate; PHP106,990 in high-value crops in Oriental Mindoro; and PHP11,400 in livestock and poultry in Marinduque. (PNA)




