
The outgoing police director recognized the sacrifices and heroism possessed by police officers in their daily duties.



MANILA – The LRT-1 Cavite Extension Phase 1 will start commercial operations this November, the Department of Transportation (DOTr) announced Thursday.

Secretary Transportation Jaime Bautista said the new LRT-1 segment will be opened in the coming weeks.

## LPA may turn into tropical cyclone within 12 hours

MANILA – The low-pressure area (LPA) east of the country may turn into a tropical cyclone, the weather bureau said Saturday.

In its 4 a.m. bulletin, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PA-GASA) said the LPA entered the Philippine Area of Responsibility (PAR) at 2 a.m. and was last spotted at 1,150 km. east of southeastern Luzon.

PAGASA said it has a high chance of turning into a tropical cyclone within the next 12 hours, although it still has no

direct effect on the country.

The country will experience generally fair weather conditions with isolated rain showers due to the easterlies or localized thunderstorms.

Light to moderate winds and slight to moderate seas will prevail across the archipelago.

Meanwhile, Typhoon Yinxing, formerly Marce, was last spotted 500 km..west of Laoag City (outside PAR), with maximum sustained winds of 155 kph and gustiness of up to 190 kph, moving west-northwestward at 20 kph. (PNA)

## LTO to open Saturdays in areas affected by 'Kristine,' 'Leon'



MANILA - Offices of the Land Transportation Office (LTO) in areas affected by the recent tropical storms will remain open on Saturdays for motor vehicle registrations, and driver's license applications and renewals.

In a memorandum, LTO chief Assistant Secretary Vigor Mendoza II said opening the LTO's district offices, extension offices, and driver's license renewal offices (DLROs) during the weekend is necessary to accommodate clients whose transactions were affected by Severe Tropical Storm Kristine and Super Typhoon Leon.

"Due to the effects of two typhoons that had hit the country and several work suspensions, which affected most of our transacting public, all Regional Directors/Assistant Regional Directors are mandated to assess the necessity of rendering services and opening offices on Saturdays," the memorandum

Mendoza ordered an assessment of the offices that need to render Saturday services with a focus on areas affected by the flooding brought by Kris-

The LTO has five district offices in Cavite, four district offices in Rizal, three district offices in Laguna, and the Batangas City and Lipa City district offices in Batangas.

"All DLROs in Calabarzon are now also preparing for the Sat-

The LTO regional office in Cagayan has scheduled Saturday operations for all district offices, satellite offices, and DLROs from Nov. 9 to Dec.

Earlier, Mendoza announced that penalties for late motor vehicle registration and driver's license renewal have been waived in consideration of those affected by Kristine.

## DA: Food supply in Christmas, stable despite disasters, ASF

MANILA - The Department of Agriculture (DA) on Friday assured a stable food supply for the Christmas season despite the effects of successive weather disturbances and African swine fever (ASF).

The DA made the assurance after the DA - Disaster Risk Reduction and Management (DRRM) Operations Center reported about 317,316 metric tons (MT) volume of production loss worth PHP6.83 billion in the agri-fishery sector due to the onslaught of Severe Tropical Storm Kristine (international name Trami) and Typhoon Leon (Kong-rey).

In an interview, DA Assistant Secretary Arnel De Mesa said supply stability is expected across all agricultural commodities with minimal price spikes expected amid the Christmas season demand.

"Walang supply (shortage) kasi nababalanse ng importation nung sa bigas, isda, sa gulay naman enough iyong production natin (There's no supply shortage because it is balanced by rice and fish importation. For vegetables, we have enough production)," he said.

The DA earlier reported the arrival of 3.7 million MT of imported rice, which is expected to cover the gap in local production, with palay production loss logged at more than De Mesa said there is also



800,000 MT, breaching the 500,000 MT to 600,000 MT annual average palay output

For fish production, which incurred 1,780 MT volume production loss amounting to PHP665.01 million after Kristine and Leon, De Mesa said the 30,000 MT of imported fish from China and Vietnam have begun to arrive by batches after the onset of the annual closed fishing season.

In terms of vegetables, De Mesa said supply remains stable with lowland vegetables expected to recover in weeks.

The DA-DRRM reported at least 37,233 MT of volume loss in high-value crops, amounting to PHP880.15 million due to the effects of Kristine and Leon.

These include the distribution of PHP541.02 million worth of agricultural inputs, including rice, corn, and vegetable seedlings, as well as drugs and biologics for livestock and poultry; a PHP500 million loanable fund through the Survival and Recovery Loan (SURE) program of the Agricultural Credit Policy, which is equivalent to a PHP25,000 loanable amount per farmer, payable for three years with zero interest; the PHP1 billion Quick Response Fund (QRF) for the rehabilitation and recovery of affected areas; about PHP667 million worth of indemnification fund; the deployment of Kadiwa food trucks for cheaper commodities; and the distribution of rice stocks from the National Food Authority (NFA) to disaster-hit areas. # DSWD requests DBM for replenishment of P875-M in quick response fund

MANILA – The Department of Social Welfare and Development (DSWD) has requested the Department of Budget and Management (DBM) for the immediate replenishment of the agency's Quick Response Fund (QRF).

DSWD spokesperson Irene Dumlao said the agency expects the QRF replenishment next week to ensure unhampered disaster response after three tropical cyclones hit the country within three weeks.

Dumlao, also Assistant Secretary for Disaster Response Management Group, said the agency still has PHP107 million in standby funds.

"We also have more than 1.3 million family food packs strategically prepositioned across the country, but we have also requested already for augmentation support from the DBM. And then currently, it is already under review)," she said, as quoted in a news release on Friday.

She said the DSWD has requested PHP875 million from the DBM, which will be directed to assistance to families affected by Severe Tropical Storm Kristine, Typhoon Leon, and Typhoon Marce, as well as future weather disturbances.


