DICT eyes more free public wifi sites in Calabarzon

Expect more free public wift in the Calabarzon region as the Department of Information and Communications Technology (DICT) is looking to onboard more public areas to benefit from its National Broadband Program (NBP).



To date, the DICT has installed free wifi in 518 strategic locations with 1,111 active access sites in Region IV-A such as town halls and public markets.

DICT IV-A Regional Director Felix Tabanao Jr. said the project will cost over P100 million to facilitate the installation of free public wi-fi and other IT infrastructure in other areas such as transport terminals, seaports, airports, among others.

"The entirety of the (NBP), considering that from the middle mile to the last mile could cost over a P100 trillion. Our national government, through Congress, is allocating funds for free public Wi-Fi and the national broadband," Tabanao said in an episode of Philippine



The program also covers internet and water. LITAW will shoulder these payments to help Filipinos.

PTFoMS remembers Maguindanao massacre, vows media protection

MANILA - The Presidential ists in the Philippines," Torres Task Force on Media Security (PTFoMS) on Saturday commemorated the 15th anniversary of the Maguindanao Massacre, pledging to continue protecting the life and rights of journalists in the country.

In a statement, PTFoMS executive director Undersecretary Jose Torres Jr. said the Marcos administration remains committed to providing a safe environment to media workers.

"This dark day in Philippine history saw the brutal killing of 58 people, including 32 media workers. We remember the victims, honor their memory, and reaffirm our unwavering commitment to protecting the lives and freedoms of journalsaid. "The massacre, one of the single deadliest attacks on journalists worldwide, serves as a stark reminder of the dangers

media workers face in pursuit of truth and accountability. It underscores the urgent need for continued vigilance and action to ensure such a tragedy never happens again."

On Nov. 23, 2009, about 58 people, including 32 journalists and media workers, were supposed to witness the filing of the certificate of candidacy of then Buluan Vice Mayor Esmael Mangudadatu for the 2010 gubernatorial elections but they were flagged down and killed by gunmen in Am-

patuan, Maguindanao.

Torres said the sacrifice of the victims of the Maguindanao Massacre would not be forgotten, stressing that the government would continue to work tirelessly to ensure that justice prevails.

Under the watch of President Ferdinand R. Marcos Jr., the Philippines will remain a "safe place for journalists to work," he said.

"A free press is essential to a functioning democracy, and we must all contribute to ensuring that journalists can do their jobs without fear of reprisal."

Torres said the PTFoMS

would strengthen its efforts to prevent and address media killings and violence.

He also promised to enhance the PTFoMS' coordination among government agencies and media organizations, especially at the local level.

He said the PTFoMS is also focused on promoting "a culture of safety and respect for press freedom."

"The PTFoMS vows to ensure that justice is served for all victims of attacks against media workers. We call on all sectors of society to join us in upholding press freedom and protecting the rights of journalists," Torres said. (PNA)

CDO village chair eyeing Congress accused of padding voters' list

MANILA – The Commission on Elections (Comelec) is set to investigate the chair of Barangay Carmen in Cagayan de Oro City's First District over suspicious fraudulent activities during voters' registration.

This after the Comelec en banc adopted the recommendation of its Election and Barangay Affairs Department and the Special Task Force for the 2025 midterm and Bangsamoro Parliamentary Elections.

Minute Resolution 24-0945

approved on Nov. 19 and released on Friday also ordered the Comelec Law department to look into the possibility of filing a disqualification case and election offense charges against the official, "who is currently running for the House of Representatives."

The Special Task Force that conducted the probe in Cagayan de Oro City said the village chair issued certifications to the applicants, who were disapproved by the Election Registration Board (ERB) of the First District on the grounds of non-residence.

Out of 21,854 applications received for the entire voter registration period, 8,218 (37.60 percent) of the applicants used barangay certifications as valid identification.

Of the applications using barangay certifications, a total of 1,161 were disapproved in Barangay Carmen for failure to appear before the ERB and to satisfactorily prove residency.

Such findings "could have been material misrepresen-

tation in the application for registration and in the issuance of the Barangay Certification by the Punong Barangay" the Special Task Force said."The Task Force respectfully herewith hasten to add that it is natural and logical conclusion that the increase of the registered voters in his very own barangay will redound ultimately to the benefit of the Punong Barangay himself, who is running for a public position in the coming May 12, 2025 National and Local Elections," it added. (PNA)

MANILA – Families affected by tropical cyclones Nika, Ofel and Pepito have now reached a total of 1,067,656 families in eight regions nationwide, the National Disaster Risk

Reduction and Management Council (NDRRMC) said in its situational update Friday.

In the same report, the agency said that the number of families are equivalent to 3,966,867 persons in 7,199 villages in the Ilocos, Cagayan Valley, Central Luzon, Calabarzon, Mi-

MANILA – Fami- maropa, Bicol, Eastern Visayas affected by tropical and Cordillera Administrative ones Nika Ofel and regions.

As of this posting, 67,971 families or 244,492 persons are still being helped in 1,913 evacuation centers while 32,764 families or 116,898 individuals are being aided outside.

There were also 12 reported fatalities but only five are confirmed as of this time.

The number of injured was placed at 14 but only 11 were validated.

Reports of three alleged missing persons are undergoing

validation.

Houses damaged numbered 52,987 and these were reported in Ilocos, Cagayan Valley, Central Luzon, Calabarzon, Bicol and Cordillera regions. Of the total, 9,197 were totally damaged.

Agriculture damage was placed at PHP52,391,642.75 and infrastructure at PHP2,712,898,584.96. (PNA)

The Philippine Statistics Authority (PSA) said the country's unemployment rate continues to drop as more industries take part in various job fairs conducted locally.

According to PSA data, over 1.89 million Filipinos are estimated to be unemployed. This was lower than the estimated number of unemployed persons at 2.26 million in September 2023 and 2.07 million in August 2024.

DA: No price cap on lechon; pork supply stable for holidays

MANILA - Agriculture Secretary Francisco Tiu Laurel Jr. said there is no need to put a price cap on pork, particularly on lechon (roasted) pig, for the upcoming holiday season despite the effects of African swine fever (ASF) in the country.

"No, I don't believe in price caps. Lalo na lechon (especially roasted pigs). Technically, it's a luxury item," he said in an ambush interview on the sidelines of the annual membership meeting of the Philippine Chamber of Agriculture and Food, Inc. on Thursday.

Tiu Laurel said that although a "minimal" price increase is expected amid the peak demands during Christmas, the country has a "stable" pork supply.

"I don't think it's going to be a big increase (in prices). I think increment, minor increase lang (only)," he added.

National Federation of Hog Farmers chairperson Chester Tan likewise allayed concerns over the holiday staple's supply stability.

"Right now, we are assuring na sa ating publiko na (the public) this coming season ng December that we have enough supply of pork even for the lechoneros, mayroon tayong (we have) enough supply," he said in a separate interview.


He said they have secured forecasts, planning, and preparation with the DA for the past two to three months.

The DA chief, meanwhile, said that the arrival of pork imports has helped strengthen the country's stocks.

"I think, we have enough supply. Actually, I was looking at the import numbers the other day, and lumalabas (it shows that) there is 10 percent more importation of pork this year than last year," Tiu Laurel said.

As of Sept. 30, more than 517.86 million kg. of imported pork arrived in the country since January, based on the DA's Trade System.

The DA has also been ramping up efforts to mitigate the impact of the ASF in the livestock sector through continugovernment-controlled ous vaccination and more strin-




