The partnership aims to imple- youth. ment programs focused on combatting online sexual abuse and exploitation of children (OSAEC), a growing concern in communities nationwide.

The collaboration outlines a multi-sectoral approach involving community stakeholders to implement awareness campaigns, educational initiatives for parents and children, training for local authorities, and the development of victim support systems.

Mayor Maricel Echevarria-Torres said the partnership marks the beginning of meaningful programs aimed at protecting the

She expressed optimism that the initiative will serve as a model for other municipalities seeking to address the rising threat of online child exploitation through community-based solutions and sustained collaboration.


For Victoria, Laguna resident Donna Talucod, 43, whose husband is a kidney transplant patient, the letter offers muchneeded relief.

PSA taps media for stories that go beyond numbers

CALAMBA CITY, Laguna (PIA) — Recognizing the media's role as story tellers, the Philippine Statistics Authority (PSA) Calabarzon organized a briefing that seeks to break down statistical data and help the public make sense of the numbers.

Attended by local media practitioners, the 'Knowing the PSA: A Media Briefing' aims to enhance their capacity in interpreting, reporting, and contextualizing official statistical data in time with the release of the 2024 Functional Literacy, Education, and Mass Media Survey (FLEMMS) conducted by the agency.

Philippine News Agency reporter Jo-Anne Stephanie Sevillano who served as the resource speaker in the event emphasized the importance of the media in bridging the gap between complex, scientific data and public understanding and education.

"That's why the role of the media is so important—because we help make sense of the numbers. For example, if inflation rises, it's the media's job to go to the market, ask real people how they stretch ₱500 now compared to a year ago. That's how we humanize the data," she stated.

Sevillano gave importance to the role of journalists in accurately translating technical information into compelling narratives that resonate with



diverse audiences, particularly at the local and grassroots lev-

Sevillano said: "Data should be the spine of the story, but not the body. We need to humanize the figures, go beyond percentages and tell the real stories behind the numbers so people at the grassroots can truly understand what's happening around

PSA also acknowledged that media practitioners play a vital role in shaping public understanding of data, and regarded them as essential partners in the agency's efforts to promote statistical literacy and responsible

"Through this media briefing this afternoon, we aim to deep-

en our collaboration with you, with all of you, our partners in the press and media, so that together we can translate this data into accurate, relevant, and engaging stories for the public. By working closely with you, we ensure that the data we gather not only informs policy, but also reaches the public in ways that are clear, accessible, and impactful," PSA Calabarzon regional director Charito Armonia said.

Topics including basic literacy and functional literacy, Consumer Price Index (CPI), inflation rate and Public-Private Partnership (PPP), employment and poverty indicators, as well as Gross Domestic Product (GDP), Gross Regional Domestic Product (GRDP) and the Provincial Product Accounts

(PPA) were also among the points discussed by the PSA IV-A as key statistical indicators vital to national and regional development.

Meanwhile, PSA also introduced its official data release protocols and online portals, including the PSA website and OpenStat database as official sources for accurate and updated information on demographics, labor, health, education, and the economy.

PSA reminded the public on the importance of getting their sources only from verified PSA platforms to avoid the spread of inaccurate or outdated figures, which can cause confusion or mislead the public. (AM,CA/



Industry, infra key drivers to CALABARZON economy — DepDev



Ongoing infrastructure programs and a growing industrial sector continue to drive economic growth in the CALA-BARZON region as it remains in its position as a top contributor to the national economy.

Ray Michael Abuso, Supervising Economic Development Specialist at the Department of Economy, Planning, and Development (DepDev) — formerly the National Economic and Development Authority (NEDA) — noted that ongoing infrastructure developments in the provinces of Laguna, Cavite, and Batangas have significantly bolstered the Regional Gross Domestic Product, valued at Php 3.10 trillion.

"All provinces in the region showed positive economic growth, reflecting growthbased economic momentum." Cavite Province recorded the highest growth rate in the region with 6.7 percent. Meanwhile, the City of Lucena—the region's only highly urbanized city—posted an even higher growth rate at 8.9 percent.

DepDev reported that the industry sector—valued at Php 1.53 trillion—contributes the largest share in the Gross Regional Domestic Product, followed by the services sector at Php 1.42 trillion and the agriculture, forestry, and fishing sector at Php 138 billion.

"Economic performance in the provinces is slightly influenced by manufacturing, infrastructure development, and sector diversification. With their industry-based economy, Laguna and Cavite, offer opportunities for residential and commercial development."

Meanwhile, Batangas Province which hosts several power plants supplying the region also shows increasing growth potential in the tourism sector.

"Overall, the CALABARZON region's economic growth is shaped by infrastructure and industry focused in the urban expansion."

To sustain economic growth, DepDev recommended long-term and province-specific solutions. These include expediting critical infrastructure projects, diversification of economic activities, comprehensive economic partnerships, and modernizing the agriculture sector—particularly in the provinces of Laguna and

Meanwhile, the provinces of Batangas and Quezon were encouraged to invest further in the agriculture sector by modernizing agricultural practices, developing value-added processing, upgrading farm-related infrastructure, and establishing agribusiness and agro-biotechnology centers.

On the other hand, Rizal Province—known for its burgeoning tourism industry—may further boost its growth by enhancing tourism infrastructure and integrating modern techniques and practices into its agricultural activities.

Housing major economic zones, the CALABARZON region contributes 14.7 percent to the National Gross Domestic Product, making it the second-largest contributor in the country. (PB/PIA4A)

11346, which mandates earmarked funds from tobacco and sugar-sweetened beverage taxes for PhilHealth.

They also demanded the remittance of unaccounted shares since 2019.

"The sin tax law is clear. A portion of revenues from tobacco and sugar sweetened beverages must go to PhilHealth to fund the delivery of healthcare services to the Filipino people. Ignoring this is a violation of the law and a disservice to our most vulnerable sectors," Cayetano said in a news release.

As Senior Vice Chairperson of the Senate Committee on Finance handling the health budget, Cayetano flagged the issue during deliberations, noting that at least PHP69.81 billion should have been allocated to Phil-Health in 2025.

She signed the bicameral report of the General Appropriations Act "with reservations," objecting to the removal of government subsidy for the agency.

Cayetano also acknowledged concerns about Phil-Health's alleged accumulation of excess funds but said this issue should be tackled independently.

"Fiscal discipline and accountability are important, but they cannot justify abandoning funds legally designated for Phil-Health," he said.

"This is about upholding the law and protecting the rights of millions of Filipinos who rely on PhilHealth coverage." (PNA)

Senator wants further probe on online games despite POGO ban

MANILA – Senator Alan Peter Cayetano on Monday urged the incoming 20th Congress to continue investigating online gaming activities in the country.

Cayetano said in a news release that despite the passage of the measure that will ban Philippine Offshore Gaming Operations (POGO), online gaming activities persist and are getting bigger.

"Ang problema, ipinagbawal na natin ang POGO, pero lumalaki naman ang online industry na puro mga Pilipino ang tumataya (The problem is we were able to ban POGO but there is an increase of online industry where Filipinos placed their bets.) I hope the next Congress can look into this," he said.

During the last session of the 19th Congress, the senator praised his colleagues with the passage of the Anti-POGO bill. He also praised opposi-



tion Senator Risa Hontiveros for spearheading a series of hearings and investigations that led to the passing on June 11.

The Senate on June 9, approved on third and final reading a bill seeking to permanently ban POGO operations in the country after 23 senators unanimously voted in favor of the neasure.

Once enacted, the law will establish an Administrative Oversight Committee, to be led by the Presidential Anti-Organized Crime Commission, tasked with ensuring the law's effective implementation.

The House of Representatives then adopted the Senate ver-

sion, which bans the establishment, operation and provision of services related to offshore gaming and POGO activities. "I want to honor those who warned us against POGO 15, 20 years ago, whatever it was called. But we acted on it only now. Sana po (Hopefully), we will act on online gaming soon in the 20th Congress," he said. (PNA)

Another client, Rowena Espiritu, a mother of four, thanked the government for the initiative, stressing that the provision of GLs is a big help for someone like her who needs maintenance medicine for hypertension.

"It eases my worries since I no longer have to think about where to get money to buy medicine. Thanks to the DSWD and Mercury Drug for this initiative," Rowena shared.

Oliver Alub, store manager of the Mercury Drug-Pedro Guevarra branch in Sta. Cruz, Laguna shared that customer visits have increased since the program's announcement.

"Many customers are coming in for quotations, typically for antihypertension, anti-angina, and diabetes medications. These quotations are then submitted to the DSWD, which determines the amount to be covered by the guarantee letter," he explained.

He also assured the public that their staff are trained and ready to assist all customers with GLrelated transactions.

The DSWD encourages the public to visit their nearest field office to learn more about the program and how to avail of GLs for medical assistance. (CM, PIA4A)

Quad com debacle

Lying, deception and treason was unearthed at the Senate committee hearing chaired by Sen Imee Marcos regarding the surrender of FPRRD by the Administration high officials to the foreign agents.

Some Filipinos, again, displayed mediocrity, it's subservience to foreigners, who are traitors, no less. Although these negative traits does not apply, in general to all, but mainly with government officials whose main focus in their respective posts is power and pocket. I don't think there will be disagreement here.

Power because the objective, this early, is to annihilate the main bulwark of opposition led by FPRRD. This is pretty obvious because what used to be the strong stand against cooperation with the International Criminal Court became the reverse or diametrically.

So far, the three Senate hearing conducted, showed nothing but a complete turned around with even DILG Secretary pointing to NSC Eduardo Ano, DOF Jesus Remulla, DND Secretary Gilbert Teodoro and himself do the planning and execution using the abusive and traitor General Torre as the hatchet man. "I don't even know if that's a real committee report. We're not afraid of it," was the response of the justice secretary and committed to cooperate with the OMB investigation. Good answer. Additionally, Sec. Remulla may also be charged of usurpation of judicial functions, grave misconduct and conduct prejudicial to the best interest of public service. Oh that's a lot for the full bloodied Caviteno to handle, who may even projected ahead what is in store for him before the bar of justice.

As most expected, as fruit of the poisonous tree,

Cabinet Re-organization

The result of the recent midterm elections, by any measure, is clearly readable even by ordinary folks. Some of the President's alter egos, either, isn't doing well or doing nothing.

The statement of PBBM when he asked for courtesy resignation, indicates that something isn't the way it should be leading to his decision to shuffle or re-organize the entire executive department.

The President was at the forefront campaigning personally for Alyansa ng Bagong Pilipinas bet. And surveys pointed to a perfect 12 potential winners from the Admin bets. The Administraresources, financially reinforced with the AKAP, AICS or Assistance to Individuals in Crisis Situation Program, among others. Billions in pesos of taxpayer's monies, were made as dole outs. By any measure, such could be considered, without winking, that it was vote buying under The COMELEC was inutile, legally or otherwise and failed to control or stop.

Given the objective condition presented and the votes going more to Duterten bets, money failed miserably to sway voters to the Alyansa side. The vulnerable impoverished poor, closer to the government officials were pampered, though. Shamelessly, most representathieves made it appear that the funds were from their own pockets. 'Ang kapal ng mga mukha.'

Goin back to the re-orga-

nization of the Executive Department, the courtesy resignation asked by President Marcos, Jr., covered the entire executive apparatus of this government from Cabinet Members to the National Government Agencies, especially those appointed by the President. As it is still ongoing, no sacred cow appeared to be spared. Hopeful. By its speech tone, PBBM seems disturbed calling the act as response to the inadequacy of government services by its officials on their respective mandate.

With poor election outcome of his Alyansa bets, he stressed that it's time "to recalibrate his Administration, not business as usual, the people have spoken and they expect results not politics." PBBM further said it's time to re-align government with the people's expectations." Of course, it

But not only that some executive officials are underperforming in pursuing their mandate for the Filipinos. Corrupt activities are unabated and appears to be the norm. In particular, corruption at DPWH sucks

billions of taxpayers money with overpriced contracts and purchases. It's surprising that resigned Sec Manuel Bonoan does nothing and with that, who would not think that he is part and parcel of the thievery in the Department which he heads.

With the opportunity presented by the demand for courtesy resignation of all Cabinet Members and their adjutants, so long as the acts indicates real good governance the President may have in mind and not a mere huge PR shot, I stand with him squarely and may even, with all humility, suggest who should be retained and who should be the replacement to the ass in the Palace.

Really, there are ass in the Cabinet which is pulling down whatever may be, if any good which the President is doing. As I sit down doing this piece, a couple few Cabinet Secretaries have been re-appointed already. DH-SUD Secretary Acuzar has been replaced with a veteran and expert construction manager, Engr Jose Ma Aliling. Expect more houses for the homeless.

DTI Secretary Cris Aldeguer Roque, re-assumed already her post, a good thing in the ongoing re-organization. There is undoubtedly neither reason nor factual basis to consider her courtesy resignation. Sec Roque is up to the task, a silent, efficient, competent and visionary worker who has contributed significantly in providing more trade, business and economic opportunities, especially the MSME's which is closer much to her heart.

The Cabinet Changes: For the better or smokescreen

The on going cabinet revamp ordered by the President of May 26 that included the heads of the 168 GOCCs on 26 May are hailed by some as a step in the right direction to re-calibrate the machinery of the government. However, others see it as a smokescreen or optics to cover up overall underperformance by some agencies and to counter the continued slide of the President's approval rating.

The President's action is unprecedented in the history of

the country. No prior President had ordered the tendering of courtesy resignation of the entire cabinet and the heads of the GOCCs (Government Owned and Controlled Corporations).

Changes in the cabinet are within the prerogative of the President and they are necessary measures to insure that the engine of the government keeps purring efficiently. But it must be done very deliberately and carefully. In the first place those in position are there after a thorough vetting and selection before they were appointed. Everyone is assumed to be fit for the job until they prove otherwise. It is the job of the President to constantly evaluate the heads of his departments and change those who should be replaced. But it must be done judiciously allowing people to go with dignity.

But the timing and the wholesale manner of the order evoked various reactions. That the President stated that the move was to weed out non-performing heads and then retained most of the cabinets, reassigned some to other positions and accepted the resignation of only a few has brought confusion to everyone. It did not help that this events came at the heels of the midterm election where the administration senatorial bets performed below expectations.

The downside of this is that it creates demoralization. Those who are let go would be perceived as having underperformed and will bring this stigma all their lives. Those retained would not feel safe either as they can be removed anytime.

I sincerely hope that these changes will redound to the benefit of the people who are reeling from increasing cost of basic commodities, horrible traffic, rising electricity, etc. I really do. The proof of the pudding is in the eating, as they say, and we will see in the coming days if this was a brilliant move or just a smokescreen and optics.

DA, DOLE to hire TUPAD workers for wider Kadiwa ng Pangulo rollout

MANILA – The Department of Agriculture (DA) and the Department of Labor and Employment (DOLE) on Monday partnered to hire workers for the wider rollout of Kadiwa ng Pangulo (KNP) programs alongside the target expansion of PHP20 per kilogram rice under Benteng Bigas Meron (BBM) Na.

DA Secretary Francisco Tiu Laurel Jr. and DOLE Secretary Bienvenido Laguesma signed a memorandum of agreement (MOA) to help both local farmers and consumers in line with the directives of President Ferdinand R. Marcos Jr.

In an interview, Tiu Laurel said the partnership will allow DOLE to supplement the DA's need for additional manpower.

"Let's say, 3,000 (KNP) outlets. 3,000 outlets na dalawang tao (two individuals) per outlet, that will entail 6,000 workers," he said.

In particular, the DOLE eyes the hiring of Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD).

On top of the 6,000 KNP operators or sellers, Tiu Laurel said at least 1,000 personnel are needed for logistics, including drivers and porters.

Laguesma, however, clarified that the total number of TU-PAD workers for KNP is yet to be determined.

Besides this, the partnership will also allow the agencies to supply PHP20 rice to more minimum wage earners under the BBM Na.

DOTr suspends cab driver's license for overcharging, probes operator

MANILA – Transportation Secretary Vince Dizon on Monday announced the immediate license suspension of a taxi driver who was caught on video trying to charge PHP1,260 for a ride from Terminal 2 to Terminal 3 of the Ninoy Aquino International Airport (NAIA) in Pasay City.

In a press conference at the Land Transportation Office (LTO) headquarters in Quezon City, Dizon said the driver has already been slapped with a temporary license suspension, with the process for permanent revocation ongoing.

"Dahil ginawa mo 'yan, irerevoke ang lisensya mo. Hindi ka na makakapag-maneho ulit ng taxi. Pasensya ka na. Kasi niloko mo kababayan natin (Because of what you did, we'll revoke your license. You won't be able to drive a taxi ever again. I'm sorry but you took advantage of the public)," he

The unit under Taxi Hub Transport has already been impounded as it was found it be unregistered. All 15 units under the company were found to have expired provisional authorities since March and are thus considered "colorum."

"Dalawa at kalahating buwan ng expired. So makakasuhan na 'yung Taxi Hub Transport na nagpapatakbo na ng colorum. Hindi ka pwede magpatakbo ng taxi ng walang prangkisa (They're expired for two and a half months now. So, we're

going to file a case against Taxi Hub Transport for operating unregistered taxis. You can't operate a taxi without a valid franchise)," he said.

He noted that both the driver and operator showed disdain for the law through overcharging while being unregistered. The distance between Terminal 2 and Terminal 3 is about six kilometers and would take approximately 10 minutes.

"Yan ang problema kapag iniisip nila na walang consequence or walang kaparusahan 'yung ginagawa nila. Ngayon mararamdaman nyo 'yung full force ng batas against this operator. Lahat na ng fleet nila, wala na 'yun. And I think, hindi na 'yan makakapag-operate uli ng taxi (That's the problem when they think there's no consequence for their actions. Now, you'll feel the full force of the law against this operator. All of their fleet, it's gone. And I don't think they will ever operate taxis again)," he said.

He warned other public utility vehicle (PUV) drivers and operators that public transport is a privilege granted by the government and comes with rules and responsibilities that they must adhere to or else face se- You won't be harassed. Don't vere consequences.

"Every action has a consequence and these are the consequences. And they will be enforced to the full extent of the law against these drivers, these operators," he said.

Crackdown vs. overcharging

To help avoid similar incidents in the future, the LTO and the Land Transportation Franchising and Regulatory Board (LT-FRB) were ordered to conduct anti-overcharging operations at NAIA, other airports, and other transport facilities such as ports throughout the country.


"I've asked the LTFRB and LTO to coordinate with Manila International Airport Authority and San Miguel Corp. through New NAIA Infra Corporation para mahuli natin lahat ng ganito (so we'll catch these violators)," he said.

He also called on the public to continue recording violations related to public transport and tag the social media pages of the Department of Transportation (DOTr) and other relevant agencies.

"Sinisigurado ko sa inyo makikita namin 'yan at aaksyunan namin 'yan, kagaya ng pag-aksyon namin nitong mga nakaraang buwan. Hindi kayo ma-iipit. 'Wag kayo matakot. Way ito para maprotesyunan namin kayo (I guarantee that we'll see your posts and we'll take action, similar to how we took action this past month. be afraid. This is a way for us to protect you)," he said.

In a video that went viral on social media, two female passengers were heard arguing and bargaining with the taxi driver, who charged them PHP1,260. The rate was lowered to PHP1,100. (PNA)

Angara: Ist day of school smooth under close gov't watch

MANILA – The first day of classes in all public schools nationwide was generally smooth under the close watch of the various government agencies, Education Secretary Sonny Angara said on Monday.

More than 27 million learners are expected to return to 48,000 public schools and 12,000 private schools in the country.

"So far, okay naman ang reports (The reports are okay), more or less smooth. May mga minor repair lang sa ibang schools na kailangan (There are minor repairs needed in other schools)," Angara said in an ambush interview on the sidelines of his visits for the opening of the School Year 2025-2026.

Angara said close coordination among government agencies is in full swing to address the needs and safety of both learners and teachers, in line with the directives of President Ferdinand R. Marcos Jr.

"Lahat ng ahensya this week, nakabantay sa ating mga paaralan, sa ating mga estudyante... Iyong buong makinarya ng gobyerno ayon sa Pangulo ay nakatutok dito sa pasukan (All of the agencies, this week are focusing in our schools, in all of our students. The entire government machinery, according to the president, are focused in the school opening)," he said.

Angara lauded the efforts of key offices, including the Departments of the Interior and Local Government, Health, Information and Communication Technology, Energy, Trade and Industry (DTI), Social Welfare and Development, Public Works and Highway, National Disaster Risk and Reduction

Management Council, PA-GASA, Meralco, Metropolitan Waterworks and Sewerage System, and Philippine National Police (PNP).

The DTI launched its Balik-Eskwela Diskwento (Back to School Discount) Caravan in Ermita, Manila to provide students, parents, and teachers with school supplies at lower prices.

Angara, meanwhile, assured they are addressing the needs of San Francisco High School in Quezon City after a fire damaged a building Sunday.


