# DOST, NAST seek to bring science closer to people



## DA wants 15% tariff retention on rice imports for stable retail prices

MALOLOS, Bulacan - The Department of Agriculture (DA) on Monday said it seeks to recommend the retention of a 15-percent tariff on imported rice to ensure the stability of the retail price.

In June 2024, President Ferdinand R. Marcos Jr. signed Executive Order 62, which reduced the tariff on imported rice from 35 percent to 15 percent to lower retail prices by at least PHP7 per kilogram.

DA Secretary Francisco Tiu Laurel Jr. underscored the need for a proper timing of tariff reversion.

"I will not increase for now dahil natapos na iyong harvest season dito at sa origin iyong mga nagbebenta (because the harvest season here and from the origin of exporting countries are already done)," he said in a media interview after meeting rice farmers here.

Tiu Laurel said he will present the recommendation in June, ahead of the tariff commission review set in July.

DA spokesperson Assistant Secretary Arnel de Mesa said the move will help ensure stability in retail prices even during lean months from June to September.

"Kapag harvest season kasi, marami kang (During harvest season, you have a high) supply. Law of supply and demand, hindi ganun kalaki iyong presyo sa presyuhan. May ginagamit kang pangtame sa presyo (the pricing is not that high. You can utilize it to tame the retail prices)," he said in a separate interview.

"Imaginin mo kapag magtaas ka ng taripa nang limited ang supply mo, limited ang harvest, mas magshu-shoot up ang presyo. Iyan ang iniiwasan natin (Imagine if you increase the tariff while having limited supply, limited harvest, the prices will shoot up. That's what we're preventing)."

The petitioner should report to the Court her compliance with this requirement within thirty (30) days from receipt of the copy of the Decree of Declaration of Nullity of Marriage.

Meanwhile, Gatchalian said "Rose," the woman who emerged from a sewer in Makati City's central business district, has decided to help the DSWD in locating and convincing individuals living in the streets and even in culverts.

After being assisted by the DSWD, Rose went out with the Pag-abot team during the reach out operations to convince other FISS to go with them and receive appropriate interventions.

With Rose's participation in the reach out, the agency is now trying out a new solution that might work out to strengthen the campaign -- for former individuals in street situations to convince street dwellers that there is a better life waiting for

"So, tingnan natin, baka itong ganitong model might work -na isa sa mga kasamahan nila dati ang magamit namin na kumbinsihin sila (So, let's see if this model might work - to use one of their numbers to convince them)," Gatchalian said.

He said the agency will continue looking for ways to help FISS in line with the directive of President Ferdinand R. Marcos Jr. to ensure that street dwellers are taken cared of at the Pag-abot Center.

"At kami, hindi kami titigil sa utos ng Pangulo, na ipaabot sa kanila ang tulong ng gobyerno, ang kalinga ng DSWD. 

### **EDITORIAL**

### **Nasty consequence**

Lying, deception and treason was unearthed at the Senate committee hearing chaired by Sen Imee Marcos regarding the surrender of FPRRD by the Administration high officials to the foreign agents.

Some Filipinos, again, displayed mediocrity, it's subservience to foreigners, who are traitors, no less. Although these negative traits does not apply, in general to all, but mainly with government officials whose main focus in their respective posts is power and pocket. I don't think there will be disagreement here.

Power because the objective, this early, is to annihilate the main bulwark of opposition led by FPRRD. This is pretty obvious because what used to be the strong stand against cooperation with the International Criminal Court became the reverse or diametrically.

So far, the three Senate hearing conducted, showed nothing but a complete turned around with even DILG Secretary pointing to NSC Eduardo Ano, DOF Jesus Remulla, DND Secretary Gilbert Teodoro and himself do the planning and execution using the abusive and traitor General Torre as the hatchet man. The Office of the Ombudsman acted already after Senator Imee Marcos urged the OMB to file charges against several top government officials involved in the arrest of FPRRD. "I don't even know if that's a real committee report. We're not afraid of it," was the response of the justice secretary and committed to cooperate with the OMB investigation. Good answer. Additionally, Sec. Remulla may also be charged of usurpation of judicial functions, grave misconduct and conduct prejudicial to the best interest of public service. Oh that's a lot for the full bloodied Caviteno to handle, who may even projected ahead what is in store for him before the bar of justice.

As most expected, as fruit of the poisonous tree,

recommended too is the filing of charges against Interior Secretary Jonvic Remulla for arbitrary detention and the Anti-Graft, and Corrupt Practices Act for inducing Torre and his Boss Marbil to violate the law aside from grave misconduct and conduct prejudicial to the best interest of the service.

FPRRD faces crimes against humanity at the ICC over his war on drugs during his terms as Davao City Mayor and Philippines President from 2011 to 2019 at the ICC. Because, not even one of the socalled victims families, not even one grandstanding Reps Flores, Castro, Paduano, Ortega, Chua, Abante came out to file case/s against FPRRD. ## The Cabinet Changes: For the better or smokescreen

The on going cabinet revamp ordered by the President of May 26 that included the heads of the 168 GOCCs on 26 May are hailed by some as a step in the right direction to re-calibrate the machinery of the government. However, others see it as a smokescreen or optics to cover up overall underperformance by some agencies and to counter the continued slide of the President's approval rating.

The President's action is unprecedented in the history of the country. No prior President had ordered the tendering of courtesy resignation of the entire cabinet and the heads of the GOCCs (Government Owned and Controlled Corporations).

Changes in the cabinet are within the prerogative of the President and they are necessary measures to insure that the engine of the government keeps purring efficiently. But it must be done very deliberately and carefully. In the first place those in position

It did not help that this events came at the heels of the midterm election where the administration senatorial bets performed below expectations.

The downside of this is that it creates demoralization. Those who are let go would be perceived as having underperformed and will bring this stigma all their lives. Those retained would not feel safe either as they can be removed anytime.

I sincerely hope that these changes will redound to the benefit of the people who are reeling from increasing cost of basic commodities, horrible traffic, rising electricity, etc. I really do. The proof of the pudding is in the eating, as they say, and we will see in the coming days if this was a brilliant move or just a smokescreen and optics.

# Marcos: Next PNP chief should focus on crime reduction

PRESIDENT Ferdinand Marcos Jr. wants the next head of the Philippine National Police (PNP) to ensure that the public would feel safe and secure at all times.

Speaking to reporters following the conclusion of the 46th Association of Southeast Asian Nations (Asean) Summit and Related Meetings held in Kuala Lumpur, Malaysia, Marcos said it is not enough that the PNP exerts efforts to further lower the country's crime rate. What's imperative is that citizens can see and feel the existence of the police force.

Citing data, the president noted that from Jan. 1 to May 16 this year, the number of recorded crimes significantly declined compared to the same period last year, when there were over 15,000 cases logged.

"When you make that comparison, everything goes down. So, they must be doing something right," he noted, pointing to the drop in statistics in the PNP's eight focus crimes — murder, homicide, physical injury, rape, theft, robbery, vehicle theft and motorcycle theft — for the first half of the year.

"And I will actually tell them, carry on what you are doing, because we have very good statistics concerning crime. Now, what we have been talking about is making policemen more visible. This is to make people feel safer. I perfectly understand that. I perfectly understand that," he added.

Addressing the country's peace and order situation is of

utmost priority of his administration, a matter he wants the successor of Police Gen. [Rommel] Marbil to have on top of his list.

Marbil wraps up his uniformed career on June 7.

The Department of the Interior and Local Government vowed to turn the president's vision into reality.

Interior Secretary JonVic Remulla inspected police operations to ensure that they are aligned with the president's aim.

"Filipinos should feel that public safety is a top priority from the moment they wake up to the time they sleep," Remulla said.

He said that the public, whether commuting early or

returning home late, should feel

"That's our aim. People must feel that the police are protecting them. People must feel that their communities are safer than before," Remulla said.

To heed the president's call, the National Capital Region Police Office has deployed 21,532 officers across Metro Manila, supported by 240 community volunteers.

Upon the orders of Marcos, the DILG also installed additional CCTV cameras nationwide to boost crime deterrence.

"This initiative is not a temporary campaign but part of a sustained and comprehensive strategy to address criminality," Remulla said.Report from manila Times

other families and individuals in street situations (FISS) or those living on the streets.

"Ang magiging intervention natin kay Rose, pangarap daw niya kasing magkaroon ng tindahan at sa assessment ng ating social worker ay kaya naman niya (This will be our intervention for Rose as it has been her dream to own a store, and our social worker has assessed that she can manage it)," Gatchalian told reporters who covered the DSWD chief's meeting with Rose.

Rose, who collects and sells recyclable garbage for a living, told Gatchalian the real story behind her photos.

She said she went into the sewer after a small blade cutter she uses for her daily collection fell into the drain. Viral photos showed snippets of her after securing the item.

Gatchalian said the DSWD would also look into how Rose's partner, "Jerome," a baker, can be assisted.

The couple lived on a street along Pasong Tamo in Makati City for a year but persevered to earn and rent a space where they could stay.

"Si Jerome, ang kanyang partner, ay dadalhin din niya sa atin baka matulungan sa training dahil marunong magwelding. So, baka matulungan sa pagbili ng welding machine para yung kita nilang dalawa mas maging stable (She will bring Jerome to us for training as he reportedly knows how to weld. Maybe we can help him buy a welding machine so that their income would become more stable)," Gatchalian said.

He said Rose has committed to help in the program by going with the Pag-abot team during reach-out operations to convince other families and individuals living on the streets to visit the center and be given appropriate interventions.

"Tutulong si Rose. Yung mga nakakasalamuha niya na kagaya niya ng sitwasyon, tutulungan niya kami na kumbinsihin sila na sumama dito sa Pag-Abot shelter para mabigyan ng tulong (Rose will help. She will help us convince other people she knows who are in a similar situation to reach out to the Pag-abot shelter so we can also help them)," Gatchalian said.

The Pag-abot Center has been in operation since 2023, catering to FISS by providing them with temporary shelter before they are returned to their respective hometowns where they can start anew through various interventions under the Pag-abot Program. (PNA)

### Public warned vs. fake RTVM account soliciting online investments

MANILA – The Presidential Communications Office (PCO) on Wednesday warned the public against scammers using a fake Facebook account in the guise of its attached agency, the Radio Television Malacañang (RTVM), to solicit online investments.

"A fake Facebook page posing as the official account of Radio Television Malacañang (RTVM) has been found circulating scam content that falsely links the agency to an online investment scheme," the PCO said in a statement.

"The fraudulent page copied RTVM's official name and profile picture, mimicking the look of a legitimate government page to deceive users. The posts on the fake page encouraged the public to participate in supposed investment opportunities, which is a common tactic in online fraud," it added.

The PCO said the RTVM's legitimate Facebook page has verified blue badge found on

legitimate government pages, while the impostor account is not verified, has low follower and engagement metrics, and contains content outside of the state-run agency's official scope.

RTVM already disowned the unverified Facebook account with misleading contents, calling on the public to be vigilant against fraudulent pages or individuals disguising as the agency.

It clarified that it "does not, and will never engage in such malicious acts," stressing that it will never "solicit or accept any form of monetary contribution or financial participation from the public."

"We apologize for any confusion or inconvenience that this may have caused," RTVM said in a Facebook post. "RTVM urges everyone to be vigilant and critical when consuming online contents, particulary from unverified and unofficial social media accounts." (PNA)

### The Iglesia ni Cristo vote

MANILA, Philippines-For decades, the Iglesia ni Cristo (INC) has been a wellrecognized force in Philippine elections, largely due to its practice of bloc voting.

1914 by Felix Manalo, has consistently instructed its members to vote as a single unit during elections, making its endorsement highly coveted by politicians.

This practice, widely known as "command voting," has cemented INC's reputation as a kingmaker in tightly contested races.

In the 2020 Census of Population and Housing, the Philippine Statistics Authority (PSA) recorded 2,806,524 members of the INC, representing 2.6 percent of the country's population. Although modest in proportion, this bloc vote is considered crucial in swing regions and tightly contested races.

Mahar Mangahas, chair emeritus of Social Weather Stations (SWS), underscored the INC's influence, saying in a recent television interview:

"From experience, Iglesia ni Cristo talagang solid yan. By solid, I mean 80 percent. not hundred ha. My feelings have always been that, but kakaunti lang sila, mga 5 percent lang ang Iglesia ni Cristo voters, so I haven't seen yet that that would change the standing so much."


(From experience, the Iglesia ni Cristo is really solid. By solid, I mean 80 percent not a hundred, okay? That's always been my impression. But there are only a few of them, around 5 percent of the voters are Iglesia ni Cristo members, so I haven't seen that significantly change the standings so far.)

Mangahas' estimate of 80 percent loyalty from INC voters is grounded in data. Exit polls have repeatedly shown that INC's command

voting is not entirely mono-

lithic but remains robust,

The church, founded in



particularly in local races. In the 2016 TV5-SWS Exit Poll, 77.2 percent of INC voters supported then-presidential candidate Rodrigo Duterte, demonstrating significant bloc

However, the bloc's influence is more apparent in races where margins are razor-thin. Historical data shows that the INC vote can provide the necessary push for candidates trailing at the edge of the "Magic 12" to secure their spots.

The numbers behind the bloc INC membership has grown steadily over the past two decades, albeit at varying rates. Data from the PSA's Population and Housing surveys reveal the following:

2000: 1,762,845 members 2010: 2,251,941 members 2015: 2,664,498 members 2020: 2,806,524 members

The compound annual growth rate (CAGR) over various periods indicates a consistent increase in INC membership from 2000 to 2010, averaging 2.48 percent per year. Growth accelerated between 2010 and 2015, reaching 3.42 percent, before decelerating to 1.04 percent annually from 2015 to

Projections for 2025 based

on historical growth rates estimate membership could range from 2.9 million to 3.3 million, depending on which rate is applied.

Regional strength and political clout

The geographic distribution of INC members further highlights its political sway.

Central Luzon (Region III), CALABARZON (Region IV-A), and the National Capital Region (NCR) host the largest concentrations of INC members, with over 1.5 million members combined. These regions are not only population-dense but also politically strategic, often deciding crucial margins in national and local races.

NCR: 441,815

## LTO revokes license of driver in NAIA car crash

MANILA - The Land Transportation Office (LTO) has revoked the license of the driver involved in the Ninoy Aquino International Airport (NAIA) crash that killed two people on May 4.

In a five-page decision signed by the LTO chief, Assistant Secretary Vigor Mendoza II, the black sports utility vehicle driver from Batangas was found guilty of reckless driving, fined PHP2,000, and had his license revoked for four years.

The victims of the NAIA Parañaque crash were a four-yearold daughter of an overseas Filipino worker from Lipa, Batangas, and a 29-year-old man from Hagonoy, Bulacan.

Autopsy showed the man died due to blunt force trauma to the head and spinal cord while the girl also died of blunt force trauma to the head and left lower extremities. (PNA)


