help reduce the country's post-harvest losses through agri-infrastructure and modernization.

Modern tech to enhance learning at Imus public school

IMUS CITY, Cavite (PIA) — In a move to modernize public education and enhance student learning experiences, the City Government of Imus officially turned over 30 state-of-the-art 75-inch digital interactive display units to Tanzang Luma Elementary School.

According to the city government, the initiative seeks to enhance classroom engagement and improve literacy by integrating advanced technology into teaching and learning.

Third District Representative Adrian Jay Advincula who graced the official turnover of the digital interactive displays, underscored the urgent need to address reading comprehension challenges among students in public schools.

"Many of our students can read, but they struggle with understanding what they read. Through these interactive display TVs, we hope to provide a more immersive and effective learning experience," Rep. Advincula said during the cer-

The interactive displays function like oversized tablets, featuring built-in operating systems, internet browsing, media playback, whiteboarding, and annotation tools—making them ideal for dynamic and studentcentered instruction.

Mayor Alex Advincula echoed the congressman's message, highlighting the need to empower both students and educators through access to modern tools and resources.



"We want our students to keep pace with global trends and equip our teachers with the skills to harness technology in the classroom," the mayor said. "Next year, we plan to install air conditioning units in every classroom to ensure that these devices operate efficiently and create a more comfortable learning environment."

The mayor added: "This development marks a significant milestone not only for Tanzang Luma Elementary School but for public education in Cavite, as it sets the tone for a more digitally inclusive and future-ready learning environment." (RF, PIA Cavite)

School tees remain voluntary, Depta

Collection of fees in public tigator of DepEd Calabarzon's schools remains strictly volun- Legal Unit, reiterated the detary and must not be used as a basis for student admission, the Department of Education (DepEd) reminded school officials as schools reopened on Monday.

Omer Licyayo, Special Inves-

partment's no-collection policy, especially for students enrolling from pre-school up to Grade 4.

The policy also prohibits schools from collecting contributions from Grade 5 to high school students for Parent-Teacher Associations (PTA) fees and public school activities during June and July.

"There are fees that schools can collect, like voluntary contributions for the BSP (Boys Scouts of the Philippines), GSP (Girl Scouts of the Philippines), and school publications. The prohibition from pre-school to Grade 4 includes voluntary contributions for BSP and GSP."

Licyayo clarified that schools may collect BSP and GSP membership fees from Grade 5 students, but only on a voluntary basis.

Aside from scouting membership fees that cost P50,

DepEd has also imposed limits on other public school contributions, including P50 for the Philippine Red Cross, P5 for the Anti-TB Fund Drive, and P60 for school paper fees.

More e-vehicle charging points sought in Calabarzon

Advocates of clean mobility have pushed for the installation of more electric vehicle (EV) charging stations in the Calabarzon region to encourage more Filipinos to go electric and promote environment-friendly vehicles on the

Engr. Ladislao Andal, chairperson of the Regional Development Council's Sectoral Committee on Infrastructure Development (SCID) said limited charging infrastructures poses a challenge in the seamless adoption of environment-friendly energy

"There is a need to intensify the establishment of charging

stations in the region," Andal emphasized.

The Department of Energy reported at least 912 publicly accessible charging stations nationwide as of March 31, 2025, which are primarily concentrated in the National Capital Region.

Andal said the EV charging infrastructure is aligned with the Philippine Energy Plan 2023-2050, the national blueprint for increasing the share of renewable energy in the country's power generation mix to at least 35 percent by

"This strategy will increase the share of renewable energy fossil fuels, enhance energy security, and decarbonize the transportation sector," Anda

Moreover, an environmentfriendly transportation sector will also help reduce carbon emission and improve air quality in Calabarzon, which is home to numerous economic zones, manufacturing hubs from car and electronics, logistics warehouses and other multinational companies.

EV users reported that most charging stations in Calabarzon are located inside industrial parks and in parking areas of select hotels.

Richard Albert Osmond, RDC co-chair and private sector representative, said golf and country clubs have also installed EV charging stations for club members and

"Most clubhouses in golf clubs have installed charging stations," Osmond noted.

Clean Air Asia, an international non-governmental organization that aims to promote better air quality and more livable cities through reduced air pollution and greenhouse gas emission, reported that a total of 9,666 EVs in the country have been registered with the Land Transportation Office (LTO) in 2022. Most of these vehicles are two-wheeler and three-wheelers that are generally used for personal or public transport.

However, the NGO admits a possible gap as registration of e-bikes, e-motorcycles, or e-tricycles has yet to be fully implemented in the country. (PB/PIA4A)



CvSU's techno demo farm to strengthen agri innovation in Cavite

INDANG, Cavite (PIA) The Cavite State University (CvSU) reaffirmed its commitment to agricultural innovation and education by partnering with the Department of Agriculture (DA) Calabarzon to establish an integrated Techno Demo Farm for research, training, and sustainable farming.

According to CvSU, the farm to be developed on a 1.3-hectare portion of CvSU's STAR Farm in Indang, is expected to strengthen agricultural innovation and education by promoting sustainable farming practices, advancing research, and empowering local farmers and students with modern technologies and skills.

"The initiative also seeks to address pressing issues related to food security, climate-resilient agriculture, and the competitiveness of local farmers in an evolving agribusiness landscape," CvSU said in a state-

Under the partnership, CvSU and DA Calabarzon will collaborate in sharing knowledge and resources while implementing programs that promote sustain-



able farming technologies and agribusiness development.

These efforts will include instruction, research, extension services, and the monitoring and evaluation of activities, policies, and technologies related to the project.

"This partnership with DA Calabarzon aligns with CvSU's mandate to conduct research and extension services, and to provide progressive leadership in agriculture, science and technology, education, and other related fields," CvSU added.

Representatives from various national and local agencies, including the Bureau of Plant Industry, Bureau of Agricultural Research, Department of Science and Technology - Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development, local agricultural offices, and farmer cooperatives, were present at the launch held recently, underscoring strong multi-sectoral support for agricultural development.

The refurbished warehouses include those in Burgos, Roxas, and Tumauini, all in the province of Isabela. These warehouses can store up to 148,000 50-kilogram bags of rice in total.

said opening of more rehabilitated NFA warehouses around the country will follow to help protect farmers from unscrupulous traders who take advantage of them by buying rice at low

"I'm very happy na nag-open tayo nito. There are 134 na bubuksan na kaya't makikinabang dito iyong farmers. In a separate statement, the DA disclosed that farmgate price of palay fell to as low as PHP10 per kilogram in some areas in the country, lower than the estimated production cost of PHP12-PHP14 per kilo.

The NFA's average buying price, however, is set at PHP18/ kg of fresh and wet palay, and PHP24/kg for clean and dry pa-

NFA Administrator Larry Lacson also said opening of rehabilitated NFA warehouses will allow them to "accommodate more palay from farmers who have waited in line for NFA to buy their harvest." (PNA)

Cavite town forms multisectoral alliance for child protection

Mayor Maricel Echevarria-Torres said the partnership marks the beginning of meaningful programs aimed at protecting

She expressed optimism that the initiative will serve as a model for other municipalities seeking to address the rising threat of online child exploitation through community-based solutions and sustained collaboration.

For Save the Children Philippines, the partnership is a "crucial step" in its Protect Children Philippines project, which aims to safeguard children of all ages and genders in the province.

General Mariano Alvarez is among the municipalities covered by the project, alongside the City of Trece Martires, Naic, Tanza, and Silang.

The DLSU-D also lauded the initiative saying that the partnership will reinforce local government and stakeholders' commitment to creating a safer online environment for children and serving as a model for other communities.

Quad com debacle

Lying, deception and treason was unearthed at the Senate committee hearing chaired by Sen Imee Marcos regarding the surrender of FPRRD by the Administration high officials to the foreign agents.

Some Filipinos, again, displayed mediocrity, it's subservience to foreigners, who are traitors, no less. Although these negative traits does not apply, in general to all, but mainly with government officials whose main focus in their respective posts is power and pocket. I don't think there will be disagreement here.

Power because the objective, this early, is to annihilate the main bulwark of opposition led by FPRRD. This is pretty obvious because what used to be the strong stand against cooperation with the International Criminal Court became the reverse or diametrically.

So far, the three Senate hearing conducted, showed nothing but a complete turned around with even DILG Secretary pointing to NSC Eduardo Ano, DOF Jesus Remulla, DND Secretary Gilbert Teodoro and himself do the planning and execution using the abusive and traitor General Torre as the hatchet man. It's a national shame that one Filipino, a PNP police general who should live up with the motto "to serve and protect," did also the reverse and lick the international tribunal agents. Firstly, so that by doing so, he will be appointed successor to the current CPNP who has the same blood type.

The Office of the Ombudsman acted already after Senator Imee Marcos urged the OMB to file charges against several top government officials involved in the arrest of FPRRD. She asked the graft body to investigate Justice Secretary Jesus Crispin Remulla, Interior Secretary Jonvic Remulla, PNP Chief Gen. Rommel Marbil and CIDG Director Maj. Gen. Nicolas

Torre III.

Sen. Marcos thinks Justice Secretary Remulla may be liable for violations of RA 3019, or the Anti-Graft and Corrupt Practices Act, for allegedly authorizing or initiating what she described as the invalid administrative arrest of former President Duterte.

"I don't even know if that's a real committee report. We're not afraid of it," was the response of the justice secretary and committed to cooperate with the OMB investigation. Good answer. Additionally, Sec. Remulla may also be charged of usurpation of judicial functions, grave misconduct and conduct prejudicial to the best interest of public service. Oh that's a lot for the full bloodied Caviteno to handle, who may even projected ahead what is in store for him before the bar of justice.

As most expected, as fruit of the poisonous tree,

recommended too is the filing of charges against Interior Secretary Jonvic Remulla for arbitrary detention and the Anti-Graft, and Corrupt Practices Act for inducing Torre and his Boss Marbil to violate the law aside from grave misconduct and conduct prejudicial to the best interest of the service.

Torre, who forcibly arrested Duterte, may be charged for arbitrary detention and violation of Republic Act 7438 for not allowing Vice President Sara Duterte to see her father and for forcing his lawyers to leave him. He, too, faces complaint of grave misconduct and conduct prejudicial to the best interest of public service.

Special Envoy on Transnational Crimes Markus Lacanilao, who appear to be better called a Special Liar may face charges for usurpation of official functions under Article 177 of the Revised Penal Code, false testimony and perjury.

FPRRD faces crimes against humanity at the ICC over his war on drugs during his terms as Davao City Mayor and Philippines President from 2011 to 2019 at the ICC. But what really is crime against humanity? No admission but maybe, the case authors think we have no justice system at works. Because, not even one of the socalled victims families, not even one grandstanding Reps Flores, Castro, Paduano, Ortega, Chua, Abante came out to file case/s against FPRRD. Maybe, just maybe, or perhaps, there was no money, then, on the take.

My readers may know better why it's a nasty, shameful consequence.

Finally, a possible path to reconciliation

What an exciting the past few days were. Top of the news that has the entire nation glued to their TV, cellphones or radios was the Oathtaking of the Senate Impeachment Court and its subsequent deliberation on the impeachment case against VP Sara Duterte last Tuesday, 10 June.

The discussions and debates were intense, sometimes acrimonious and long which centered on

the Resolution introduced by Sen Bato dela Rosa to dismiss the case. Sen Alan Cayetano followed up with an amendment to Sen Dela Rosa's resolution, not to dismiss it outright but to remand the articles of impeachment back to the HOR. The result was 18-5 in favor of remanding the case back to the HOR with two key orders. First,

Congress. But others said it will.

The HOR prosecution panel, however, were delighted because according to them the Senate's act of sending summons to the VP means it has taken cognizant of the case. And because of this,

they argue that no one can stop the impeachment trial from crossing over to the 20 th Congress and for the trial to proceed until judgment by the Impeachment Court is promulgated.

Everyone is gearing up for a "bloody" court fight starting July. And this will be a contentious,

emotional and acrimonious court case with the accompanying hype, drama and propaganda.

Does this exercise ben-

efit the Filipino people? In fact. this impeachment trial has been sapping the strength and vitality of the nation. It has effectively relegated to the background the shortcomings of the government in addressing the needs of the people. Whether this is the object or just the collateral damage the fact remains the people are the ultimate losers here.

But what if we look at the remanding in another lens, another perspective? What if this is in fact a providential act paving a path to reconciliation? What if PBBM is being given a golden opportunity to stop this impeachment once and for all. Because we know that this is just a plot to

this is just a plot to remove the VP and make her irrelevant before the 2028 election. Maybe it's time for PBBM to use its bully pulpit power to dissuade the HOR to stop it.

And after succeeding in stopping the impeachment for good, PBBM could start the process of bringing PRRD back from the Hague to the Philippines where he could be tried for alleged crimes committed. This will be real reconciliation. The country is beset with so many pressing problems. Let us henceforth heal this pestering division and focus all our energies to serving the needs of the people and not spend resources and time in this divisive and acrimonious

impeachment.

Big-time fuel price hike seen next week

MANILA - Prices of petroleum products may increase by nearly PHP5 per liter next week, a Department of Energy (DOE) official said Friday.

In a Bagong Pilipinas interview, DOE - Oil Industry Management Bureau (DOE-OIMB) Director Rino Abad said the increases will range from PHP2.50 to PHP3.00 per liter for gasoline, PHP4.30 to PHP4.80 per liter for diesel, and PHP4.25 to PHP4.40 per liter for kerosene.

"Bunsod iyan ng tumaas na almost average of 4 US dollars per barrel doon sa gasolina, diesel at kerosene (That is due to an increase of almost an average of USD4 per barrel in gasoline, diesel and kerosene)," Abad said.

The world price of crude oil increased to USD86.6 per barrel on Thursday from USD83 on Monday.

"Unfortunately, for next week,

iyong apat na trading days ngayon, Monday to Thursday, mayroon na ho tayong pag-i-increase na aabot ho ng (the four trading days now, Monday to Thursday, we already have an increase of) almost PHP3 pesos per liter for gasoline and more than PHP4 pesos for diesel and kerosene," Abad said.

While the Philippines does not import oil directly from Iran, which is currently locked in an armed conflict with Israel, he said suppliers may be getting their oil from the said country.

The agency monitors the country's refiners and direct importers on a weekly basis to check any report of supply disruption.

"Last week, may nakausap po

tayo specifically iyong Petron, iyong Unioil for example, wala po ngayong narereport sa kanila (we spoke with Petron, Unioil for example, nothing was reported them)," Abad said

"Ngayong araw nagka-usap din tayo sa LPG sector naman, wala hong reported na anggulo or situation na na-i-experience nila na mayroong supply disruption (We spoke with the liquefied petroleum gas sector today and no supply disruption was reported)," he added.

Abad assured the public that the DOE will continue to meet with individual oil companies Wednesday to Friday next week to discuss the inventory and discount program. (PNA)

DA chief: Isabela farmers back calls to restore NFA's powers

MANILA – Farmers from some para mapaganda ang takbo ng of the country's major riceproducing areas backed calls to restore the regulatory functions of the National Food Authority (NFA), Agriculture Secretary Francisco Tiu Laurel Jr. said Friday.

Tiu Laurel said Isabela farmers also favor the amendment of the Rice Tariffication Law (RTL) to grant NFA the powers to help protect them from unscrupulous traders and perform market intervention through rice sale when necessary.

Kailangan talaga ma-amyendahan (RTL is really a concern. It needs to be amended)," he told journalists at the sidelines of his inspection of an NFA warehouse in Roxas, Isabela.

"At galing na rin sa mga farmers natin dito na talagang gusto nilang ma-amyendahan iyan

rice industry natin (According to our farmers here, they want it amended to help improve our rice industry)."

Tiu Laurel earlier said restoring NFA powers under the RTL is crucial in coming up with the floor price for palay (unhusked

The floor price, which refers to a state-imposed minimum price for goods or services, should at least cover the production cost of farmers.

"Talagang concern iyong RTL. The estimated production cost of palay ranges between PHP12/kg to PHP14/kg, according to the DA. This is higher than the PHP10 per kg. that farmers reported as traders' buying price in some areas in the country at the tail-end of the harvest season.

> With regulatory powers in place, the NFA may secure a

registry of both farmers and traders which will help monitor palay procurement prices.

Other countries like India, Thailand, and Indonesia, among others, have been implementing floor prices of palay for traders.

Tiu Laurel also assured to address those who are using the government's "Benteng Bigas Meron (BBM) Na" as an excuse for granting reasonable buying prices.

"Sinabi ko rin sa ating mga farmers na kakausapin namin next week iyong mga traders sa rice mills na huwag gamitin iyong PHP20 na programa para baratin nila ang ating mga farmer (I also told the farmers that we will talk with rice traders next week to prevent them from using the PHP20 rice program to take advantage of our farmers)," he added. (PNA)


