people trust them. People will trust them if these public officials govern with accountability and integrity," he said





trust us. Remember that running for a position and occupying a position is always for public service, not personal interest."

DBM OKs P2K across-the-board allowance hike for teachers, poll workers



MANILA – The Department of Budget and Management (DBM) has approved the PHP2,000 across-the-board increase in the compensation of teachers and other poll workers serving in the May 12 midterm elections.

In a statement on Friday, the DBM announced the new and higher honoraria rates for those in the Electoral Board.

The DBM said the chairperson will receive PHP12,000 instead of PHP10,000, while poll clerk and the third member will get PHP11,000 instead of PHP9,000.

Around PHP8,000 will be given to the support staff, higher

than the previous PHP6,000.

"This is a realization of the directive of President [Ferdinand R. Marcos Jr.], who is truly committed to ensuring we provide needed support for the welfare of our teachers," DBM Secretary Amenah Pangandaman said.

There are around 758,549 poll workers for the national and local elections, data from the Commission on Elections (Comelec) showed.

Based on the Election Service Reform Act and Comelec Resolution 10194, persons rendering election service shall be entitled to honoraria, travel allowance, communication allowance, meal allowance, and service credit.

The DBM said the budgetary requirement for the poll workers' compensation and as authorized under the 2025 General Appropriations Act is PHP7.480 billion.

Pangandaman called on concerned agencies to ensure the timely release of higher compensation for teachers and poll workers this coming elections. "I urge Comelec to ensure that our teachers and poll workers will get their compensation as quickly as possible. Dapat timely ang release ng kanilang benepisyo (The release of their benefits should be timely). They deserve nothing less," she said. (PNA)



We're in trouble

Consequently, from consistent upward trust rating since assuming the Presidency, PBMM's dropped at an unprecedented level recording the lowest survey rating in 3 years.

The survey, done 4 days after the "kidnapping" of Duterte led by that PNP's abusive idiot Gen Torre from March 15 to 20 conducted by PUBLiCUS Asia Inc., indicated a huge shift in public sentiment. Surprisingly, the HOA President noted the letter which in addition was addressed to a non-existent human. Apparently, this is forgery.

TULAY takes note and monitors the activities and workings of the HOA's all over the land in support of DHSUD effort to ensure that HOA's are up to the job. What comes next, we will let our readers know.

The P20/kilo rice (Un) Fulfilled Promise

Early in his administration PBBM promised to lower the price of rice to P20/kilo. The populace waited with bated breaths as rice is the staple food and constitute a major part of the daily food expense of the Filipino household.

On May 1st the Department of Agriculture finally rolled out this long-promised P20rice by the President. With much hoopla and hype this was finally done starting last May 2 thru the Kadiwa stores in Cebu. The LGUs in Cebu City and adjacent towns were likewise selling the P20 kilo rice subsidizing the P13 the difference from the market price of P33 pesos.

But immediately after it was started the COMELEC has cautioned that the scheme cannot be done by LGUs as it violates the vote buying prohibition by the COMELEC. The Kadiwa Centers, however, could continue to sell the P20 per kilo rice.

This was hailed by the administration as a "promise fulfilled". But it was also criticized by many that it was for election purposes only. Many asked why was it done in Visayas only? And why near election day and

in vote-rich Cebu? Are the other regions not deserving of cheap rice? VP Duterte says it is not fit for human consumption which was belied by the DA.

There were official reasons why this was done at this time. DA says it needs to sell its stockpile to make way for new importation. The DA Likewise says it has allocated P3.5 tov4.5B pesos for this roll out.

Economists were quick to comment that funding will be a huge challenge for this roll out. According to them the Bureau of Treasury showed a P103B peso deficit for the first 2 months of 2025. Last year the budget deficit was 1.5T pesos. They warned that subsidies will only worsen

the government budget deficit.

One opinion writer termed this project as quack economics. "The economics driving the P20/kilo rice is just as unsound and unhinged as Trump's tariffs. There is no way the global trading system would survive those levies. The P20/ kilo rice is a policy of utter desperation and craziness, with no basis in the real world and in agricultural economics. There is no circumstance or environment that would make the P20/ kilo rice sustainable" he

The cost to the government will be huge. Sec Laurel of Agriculture said that the Marcos administration is ready to spend ₱10 billion to ₱12 billion to subsidize the upcoming pilot run of its ₱20-per-kilo rice program in the Visayas region and Kadiwa ng Pangulo (KNP) stores. In a briefing on Tuesday, April 29, Laurel said the government has authorized the redirection of ₱5 billion from the national government's contingency fund to the state-run Food Terminal Inc. (FTI).

How long will this P20/kilo rice last? My estimate is not very long due to the law of supply and demand- demand will outstrip supply. And more importantly the government cannot sustain the subsidy.

The P20/kilo rice may be a good optics but it is not sustainable and it will ruin the fiscal position of the country.

DepEd: CSC nod for high school grads in gov't opens doors for learners

MANILA - The Department cation Secretary Sonny Angaof Education (DepEd) on Friday lauded the Civil Service Commission (CSC) for allowing the hiring of Junior High School (JHS) and Senior High School (SHS) graduates in first-level positions in the government.

The CSC promulgated Resolution No. 2500229 on March 6, formally recognizing Grade 10 and Grade 12 graduates under the K to 12 (Kinder to Grade 12) curricula as eligible for first-level government positions.

This is in line with the directives of President Ferdinand R. Marcos Jr. to ensure the employability of graduates of basic education and address job mismatch in the country.

"We thank the CSC for this landmark decision. It not only opens new doors for our learners but also boosts the government's talent pool with fresh, young professionals trained under our K-12 system," Edura said in a statement.

In particular, the CSC revised qualification standards for entry-level positions in "clerical, trades, crafts, and custodial services."

These include structured and sub-professional work, which will be beneficial especially to graduates under the Technical-Vocational-Livelihood track.

Angara said the CSC's move sends a "powerful signal" to both K-12 graduates and their parents that the basic education curriculum delivers "real employment opportunities."

"For years, our SHS students have been trained to be workready, but policy gaps kept them from entering the public sector. This reform finally bridges that divide," he said.

With the new policy in place, JHS and SHS graduates may be hired in the public service once they secure relevant requirements, including experience, training and eligibility for purposes of appointment to said positions. (PNA)

"It can also be done online, before filing a case in court or with a labor arbiter, it is first discussed through a conciliation-mediation conference. The goal of SENA is to resolve issues within just 30 days, without the need for a long process and costs," the director explained.

Hope rises for Philippines' Cardinal Tagle as Pope Francis' successor

VATICAN – Among the massive crowds of people waiting for the first round of smoke to emanate from the chimney of the Sistine Chapel, several Filipino Catholic pilgrims were hoping for the Church to be led by a pope who is one of their own: Cardinal Luis Antonio Tagle.

Fr. Rey Matunog of the Archdiocese of Los Angeles said he believes that Cardinal Tagle possesses all the qualities needed to become the next pope.

He led a group of 46 Filipino Americans from Southern California in an annual pilgrimage to Rome and Switzerland. Matunog shared that their group made a special trip to the Vatican to show their support for Cardinal Tagle.

"We believe in the power of

the Holy Spirit. I hope the cardinals will be touched by the Spirit when choosing the next pope. Our faith is important now more than ever," Fr. Matunog told Inquirer.net.

"We pray that one of our Filipino cardinals, especially Cardinal Tagle, will be chosen as the new pope because it would be a blessing not only for the Church but also for Filipinos worldwide."

The doors of the Sistine Chapel have closed after the cry of "extra omnes" — Latin for "all out" — and 133 red-robed cardinals — including Cardinals Tagle, Jose Advincula, and Pablo Virgilio David — began the secretive, centuries-old ritual of electing a new pope to lead the Catholic Church.

They entered the Sistine Chapel in pairs, chanting the meditative "Litany of the Saints" as Swiss Guards stood at attention. The hymn implores the saints to help the cardinals find a successor to Pope Francis

to lead the 1.4 billion-strong Catholic Church.

If voting is ongoing and a pope has not yet been elected, black smoke will billow from the chapel's chimney.

White smoke will signify that one of the 133 cardinals has secured two-thirds of the votes to become the next pope.

It is unlikely that a new pope will be elected on the first day of voting.

There is no fixed schedule for how long the conclave will

last. In 2013, Pope Francis was elected in just one day, but historically, some papal elections have taken years. In 1271, Pope Gregory X's election had taken three years.

The current conclave is expected to unfold over the upcoming days, with the first ballot scheduled for this evening at 7 p.m. Vatican time.

Voting will occur four times each day – twice in the morning and twice in the evening – until a candidate secures enough votes to become the next pope. /nur

Warm weather, rains to prevail across PH



MANILA – No low pressure area is being monitored, and the easterlies affecting the country will bring high chances of rains and thunderstorms over the eastern section of Central Luzon, a forecaster said on Friday.

"For the rest of the country, the easterlies will cause warm weather, especially at noon, and sudden rains and thunderstorms in the afternoon and evening," Grace Castañeda of the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) said.

PAGASA predicted the easterlies to bring scattered rains and thunderstorms over Aurora.

"Take precautions against possible flooding and landslides," Castañeda warned.

Light to moderate winds and slight to moderate seas continue to prevail across the archipelago.

Meanwhile, up to 35°C temperature is forecast in Tuguegarao; up to 34°C in Metro Manila, Kalayaan Islands, Zamboanga and Davao.

Castañeda said the heat index, or the temperature felt by the human body when relative humidity is factored in with actual air temperature, could peak at 40°C to 42°C in Metro Manila.

"A danger level heat index of 42°C to 43°C in some areas in Ilocos Region, Cagayan Valley, Central Luzon, Calabarzon, Mimaropa, Bicol Region, a huge part of the Visayas, and some areas in Caraga and Zamboanga Peninsula," she

Under "danger" level conditions, which range from 42°C to 51°C, the public is warned of increased risks of heat cramps, heat exhaustion, and heat stroke with prolonged exposure. (PNA)


