Electronic ticketing to be introduced in PH seaports

The Department of Transportation (DOTr) has announced plans to reintroduce an electronic ticketing system at seaports including Batangas Port, aiming to streamline passenger processing and bolster safety measures.

"They [DOTr and PPA] want to relaunch the electronic ticketing management system or ETMS so that [passengers] can book ticket purchase through online and can save time and no longer need to line up to buy, just at least from the comfort of your home you can buy there your tickets", DOTr Spokesperson for Business Infrastructure Maricar Bautista said during the PIA Ugnayan at Talakayan sa Laguna program.

Batangas Port, one of the Philippines' busiest maritime hubs handling an average of 20,000 to 25,000 passengers daily, is among the key ports that stand to gain significantly from the reimplementation of the ETMS especially during peak travel seasons such as Holy Week and Christmas, where this number can surge significantly.

ETMS is a digital platform designed to manage booking, payment and issuance of ferry



or port tickets online, primarily for passengers using roll-on/ roll-off (RoRo) ports and ves-

It was previously suspended in September 2022 and officially discontinued in 2023 under former Transportation Secretary Jaime Bautista. However, DOTr's new chief Vivencio Dizon emphasized the system's potential to restore order

particularly during peak travel periods.

"Let's take advantage of what we have modernized. The PPA plan is to revive it [ETMS] and even Secretary Dizon said before the year ends it will be implemented so let's just wait for it and will just give more updates", Bautista stated.

In a statement, Gatchalian said if left unchecked this could drive away tourists and undermine confidence in the country's airport system.

"The reported 'punit passport' scheme is a serious threat to our country's reputation as a tourist destination," he said.

Gatchalian said authorities should immediately hold those responsible accountable, adding the Department of Transportation (DOTr) and airport authorities should formulate security protocols that ensure the safety of passengers without compromising convenience and comfort.

DOTr Secretary Vince Hizon has issued warning on the reported scheme, which happened in some airports in the country resulting in the offloading of passport holders.

Hizon advised passengers bound for international flights to always check the validity and condition of their passports before traveling and to consult with passport centers or airport authorities when in doubt.

Under the Philippine Passport Act, a passport is considered damaged if its physical condition is altered due to wear and tear, aging, negligence, or other factors that leave it mutilated or defective.

A passport is deemed mutilated if its data page becomes unreadable or if any information is missing. (With report from Leonel Abasola/PNA)

The DA is piloting the initiative in the Visayas, targeting around 800,000 households – or roughly four million individuals – in areas with high poverty and food inflation, such as Cebu.

Citing Philippine Statistics Authority data, De Mesa said the region was selected based on its vulnerability to food insecurity and rising consumer prices.

De Mesa clarified that the program is not new, but rather an expansion of existing DA efforts such as the "Rice for All" and the PHP29 rice programs.

He explained that the initiative comes when the National Food Authority (NFA) is holding surplus rice stocks from recent peak harvests and is expected to purchase an additional 500,000 metric tons because its budget has been increased.

He said NFA currently buys palay (unhusked rice) from farmers at PHP23 to PHP24 per kilo, above the prevailing farm-gate prices. While the rice is sold to the public at a subsidized PHP20 per kilo, De Mesa said the real selling price to the Food Terminal Inc. (FTI) is PHP33.


The gap is funded through a PHP5-billion subsidy - - PHP4.5 billion for rice cost-sharing and PHP500 million for logistics and packaging. Participating local government units also contribute PHP6.50 per kilo in shared subsidy.

Although the DA remains a technical agency, De Mesa said its mandate now requires decisive action.

Araw ng Kagitingan: A Testament to Courage and Sacrifice

Each year on April 9, the Philippines observes *Araw ng Kagitingan*, or the Day of Valor, to honor the resilience and sacrifice of Filipino and American soldiers during World War II. This day marks the 1942 surrender of the defenders of Bataan Peninsula, a pivotal event followed by the infamous Bataan Death March. More than a historical milestone, the day serves as a solemn reminder of the horrors

of war and the enduring spirit of those who faced unimaginable adversity.

In December 1941, Japan launched a swift invasion of the Philippines, a strategic target due to its proximity to vital Pacific trade routes and natural resources in the Dutch East Indies or what is now Indonesia. Under General Douglas MacArthur, combined Filipino and U.S.

forces mounted a desperate defense, retreating to the Bataan Peninsula and Corregidor Island. Despite shortages of food, medicine, and ammunition, the defenders held out for three months, delaying Japan's timetable to conquer the whole south east asia and buying Allies crucial time. When MacArthur was ordered to Australia, General Edward King assumed command, facing an inevitable surrender by April 1942.

On April 9, 1942, approximately 76,000 exhausted troops (60,000 Filipinos and 16,000 Americans) surrendered, marking the largest U.S. military surrender in history. What followed was the Bataan Death March—a 65-mile forced trek to Camp O'Donnell. Prisoners endured extreme heat, starvation, and brutal treatment; many were executed for faltering. Historians estimate 10,000 Filipinos and 650 Americans perished, their suffering emblematic of wartime inhumanity. The march, later deemed a Japanese war crime, became a symbol of both cruelty and endurance. Designated a national holi-

Valor is marked by ceremonies at Mount Samat's *Dambana ng Kagitingan* (Shrine of Valor), featuring a towering cross and museum. Government officials, veterans, and foreign dignitaries gather for wreathlaying, speeches, and moments of silence. Schools host educational programs, ensuring younger generations understand this legacy. In the U.S., states like New Mexico-home to many survivors-also hold memorials, reflecting the shared history between na-

Through annual observances and education, the legacy of Bataan endures—a beacon of hope and a cautionary tale, urging humanity to strive for a world where such valor is never again necessitated by war.

PBBM: Gov't holds 69 job fairs nationwide



MANILA – The nationwide job fairs in 69 areas in the country will run until May 2, in time for the Labor Day celebration, President Ferdinand R. Marcos Jr. said Thursday.

Marcos said the simultaneous events are held in Central Luzon, Calabarzon, Western Visayas, Central Visayas, Northern Mindanao, and Davao Region.

"Hindi lang po tayo gumagawa ng mga pagkakataon at oportunidad para sa mas maraming trabaho. Inilalapit din po natin sa ating mga kababayan ang trabaho sa pamamagitan nitong kagaya ng ginagawa natin ngayon mga job fair (We are not only creating opportunities for more jobs. We are also bringing jobs closer to our countrymen through this, just like we are doing now with job fairs)," he said during the 123rd Labor Day celebration at SMX Convention Center in Pasay City.

Marcos noted that from July 2022 to February 2025, over 4,000 job fairs have been organized in the country where one million Filipinos took part and 170,000 were hired on the spot.


He said there is a one-stop shop at the job fairs to make it "easier, faster and more organized" for applicants to get the pre-employment requirements from participating government agencies.

Marcos stressed that the government is also strengthening the Technical-Vocational-Livelihood-Track in senior high schools to ensure that basic education graduates will have certification from the Technical Education and Skills Development Authority (TESDA).

He said the micro-credentialing system in technical-vocational education and training was launched in March this year to allow workers to complete short modules and get modular certification even if they have not completed the entire course.

"Pwede po nilang ipunin ang mga sertipikasyon upang maging bihasa, na siya naman ay magbibigay-daan para sa mas magandang trabaho (They can compile certifications to become skilled, which in turn will pave the way for better job)," Marcos said.

Comelec orders 5 bets to explain alleged vote-buying



MANILA – The Commission on Elections (Comelec), through its Task Force Kontra Bigay, has ordered five candidates in the May 12 elections to explain why they should not be slapped with vote-buying charges in connection with their respective campaign activities allegedly involving the distribution of gifts and financial assistance.

The show cause orders (SCOs) were issued separately against a candidate for mayor and vice mayor in Oriental Mindoro, two congressional candidates in Nueva Ecija and Palawan, and a candidate for a national post.

The two local candidates in Oriental Mindoro were issued SCOs in connection with evidence filed before the committee dated April 7, 2025, showing them facilitating the distribution of PHP2,000 to each recipient under the pretense of a work program of the Department of Social Welfare and Development at a covered court.

The candidate from Nueva Ecija was ordered to explain the video on his social media account showing him asking the support of the people with a promise of giving them money, while the candidate in Palawan was ordered to explain his distribution of free movie tickets.

Meanwhile, the national candidate was ordered to explain her participation in an event in Imus, Cavite on Feb. 16, 2025 amid photographs showing her "delivering a speech and engaging with participants, including instances where individuals were shown visibly holding cash while embracing you."

The five candidates were directed to submit their respective answers via courier or electronic mail.

"You are hereby warned that failure on your part to comply with the SHOW CAUSE OR-DER shall be considered as waiver of your right to be heard and the filing of the appropriate case/s against you," the Comelec said. (PNA)

NSCR gets final funding tranche from ADB

The Department of Transportation (DOTr) announced that the Asian Development Bank (ADB) has approved the 1.4-billion US dollar second and final tranche for the construction of the North-South Commuter Railway (NSCR).

Maricar Bautista, Spokesperson for Business Infrastructure said during the Ugnayan at Talakayan sa Laguna program that the funding is for the construction of the Malolos to Clark segment of the railway project slated to be finished by 2028.

"Two weeks ago, Secretary Dizon visited the project sites at the Malolos and Clark stations of the NSCR and ordered the contractors to speed up the construction of the projects so the commuters can use the rail system as early as possible."

The NSCR project, spanning 147 kilometers, will connect key cities in Pampanga, Bulacan, Metro Manila, Laguna, reducing end-to-end travel time between Clark International Airport in Pampanga and Calamba City in Laguna to less than two hours.

Once fully completed, the



NSCR is expected to benefit measures and efforts are being approximately 800,000 passengers daily by significantly reducing travel time between the northern and southern parts of Metro Manila and Calabarzon region. It will also help decongest Metro Manila and alleviate the daily struggles of the commuting public.

The railway system is also seen to play a vital role in helping the Philippine economy thrive.


